Sub: Visit of DG, SAI to SAI Regional Centre, Guwahati on 17th June, 2015

The undersigned visited Lakshmibai National Institute of Physical Education (LNIPE), Tapesia, SAI Regional Centre (RC), Guwahati on 17th June, 2015. Gist of decisions emerged during the said visit are indicated hereunder for appropriate action by the concerned Division :-

(1)	<p><u>LAXMIBAI NATIONAL INSTITUTE OF PHYSICAL EDUCATION, NORTH EAST REGIONAL CENTRE, TAPESIA</u></p> <p>With Memorandum of Understanding between Ministry of Youth Affairs and Sports, Govt. of India, LNIPE and Ministry of Sports and Youth Welfare, Government of Assam, the LNIPE, NERC, Guwahati was established in the year 2010. It is located in an area of around 80 acres of land situated in Tapesia, Sonapur, Assam which is about 16 kms. away from the City of Guwahati.</p> <p>MOS (I/c), YA&S has approved the establishment of a SAI-LNIPE Archery Academy in LNIPE, Tapesia. Presently, the following infrastructure is readily available for immediately starting of the Archery Academy:</p> <ul style="list-style-type: none">• 80-bedded furnished accommodation for the inmates with all basic amenities• 25m Swimming Pool• A modern High Tech Gym• A multipurpose Indoor Hall with playing area of 60m x 45m• Space for Archery Range which requires up-gradation. <p style="text-align: center;">} <i>On sharing basis</i></p> <p><u>Additional Points :</u></p> <p>For immediate opening of the proposed archery academy, following points are to be taken care of :-</p> <ol style="list-style-type: none">i) A formal communication to the Vice Chancellor, LNIPE, Gwalior is to be issued from the Ministry of Youth Affairs & Sports, Govt. of India.ii) Procurement of Sports Equipment.iii) Follow up action of the admission procedure through talent scouting.iv) Finalization of the Date of inauguration.	<p>Regional Head of SAI RC, Guwahati and Dean, LNIPE, NERC, Tapesia for preparation of detailed plan & Estimates.</p> <p>SAI Head Office, New Delhi – to follow up.</p> <p>Regional Head of SAI Regional Centre, Guwahati and Dean, LNIPE, NERC, Tapesia</p>

(2)	<p><u>INSPECTION OF REGIONAL CENTRE, GUWAHATI</u></p> <p>The Centre is located in the heart of the Guwahati City comprising 9.3 acres of land. The plot of land was handed over by the State Govt. of Assam to the SAI on lease for 99 years @ Rs.1/- per year. In the year 2013, Sub Centre, Guwahati was upgraded to Regional Centre, Guwahati. At present, SAI Regional Centre, Guwahati is looking after various SAI promotional Schemes viz. STC, SAG, NSTC, Extension Centre, Akhara & ABSC in four North Eastern States, namely, Assam, Meghalaya, Arunachal Pradesh & Sikkim.</p> <p>The Regional Centre, Guwahati has been at the forefront in promotion of excellence in Sports since its inception. The Regional Centre premises, though 9.3 acres of land as per official record, has only 7.5 acres. The centre is running 9 disciplines under STC scheme with optimum utilization of the available area and infrastructure.</p> <p>The following infrastructure is required to be upgraded:-</p> <p>1. <u>Upgradation:</u></p> <p>a) <u>Multipurpose Indoor Hall :</u></p> <p>Approval and sanction for re-laying of wooden flooring of the Multipurpose Indoor Hall has already been given to the Centre. In view of the climatic condition of the region, wooden flooring may not be suitable due to very high humidity and vulnerability to termite infestation. The existing wooden flooring which was done by CPWD lasted for less than 3 years. Therefore, instead of wooden flooring, synthetic surface is to be installed with the following additional works within the sanctioned amount :-</p> <ul style="list-style-type: none"> i) Construction of additional change rooms. ii) Construction of Fitness Centre on the space available in the terrace. iii) Painting of inside & outside. iv) Renovation of change rooms & toilets etc. <p>b) <u>Up-gradation of existing Football Ground :</u></p> <p>The FIFA has provisionally selected the SAI football ground as one of the practice ground for under 17 World Cup Football tournaments to be held in 2017. Therefore as suggested the practice ground need to be upgraded as per FIFA requirements.</p>	<p>Submission of fresh estimates by SAI Regional Centre, Guwahati and Director (Infra.)</p> <p>Submission of estimates by SAI Regional Centre, Guwahati and further action by Director (Infra.)</p>
