Sub: Visit of DG, SAI to SAI, WZTC, Aurangabad on 29th June, 2015.

The undersigned visited SAI, West Zone Training Centre (WZTC), Aurangabad on 29th June, 2015 in connection with the visit of the Parliamentary Committee on Laying of Papers on the Table of Lok Sabha. The gist of decisions taken during the visit is as under for appropriate action to be taken by the concerned divisions:-

	<p>On the basis of decision taken during the SNIPES meeting held at New Delhi in the year 1986, a recommendation for the establishment of NIS Western Region Centre at Aurangabad was duly forwarded by the Member Secretary to the Government of India for approval subject to the State Government making available required land at Marathwada University, Aurangabad and financial assistance of Rs. 2.00 Crore for the development of the Centre.</p> <p>Accordingly, an agreement was executed on 6th March, 1987 between the authorized representative of Dr. Babasaheb Ambedkar Marathwada University and the erstwhile NIS Patiala for handing over land admeasuring 99 acres 7 Gunthas on lease for the period of 99 years. This centre was established as West Zone Training Centre in the year 1986. During the course of time, various sports facilities & infrastructure have been created/developed in phased manner at this centre.</p> <p>The centre is located in the heart of city and has over a period emerged as an important SAI centre for promotion of excellence in sports. It is being used regularly for holding National Coaching Camps and conducting various academic programmes, apart from running SAI promotional schemes in ten sports disciplines.</p> <p>Around 40 acres of land have been utilized so far in creating the existing infrastructure & play fields and a plenty of land is available, which could be used for development of new infrastructure. II	<u>CREATION OF NEW INFRASTRUCTURE :-</u>	
(i) & (ii)	<p><u>Synthetic Hockey Surface :-</u> & <u>Synthetic Athletic Track:-</u></p> <p>Administrative approval for the above two projects was accorded in the 52nd Finance Committee Meeting held on 01/05/2008. Accordingly, estimates have been obtained from CPWD and forwarded to SAI head office.</p> <p>Given the huge potential of this area, it is necessary to take up the projects on priority. Accordingly, the laying of hockey synthetic turf may be taken up immediately. Director (Infra.) may take necessary action in this regard. The athletic track may be taken up under the scheme of assistance for creation of urban sports infrastructure. Since the land has been leased out to SAI by Aurangabad Municipal Corporation, they can apply through the State Government. These facilities can be used for conduct of National Coaching Camps as well as by STC inmates.</p>	Director (Infra.)/ Director In-charge, Maharashtra Region / In-charge, SAI Aurangabad Centre
(iii)	<p><u>Construction of Cycling Tar Track :-</u></p> <p>As there is sufficient land available at this centre, 5000 Mtr. Cycling Tar Track may be laid in the periphery of premises adjacent to boundary wall. At present, no such facilities are available in any of the SAI Centre in Western Region. This facility could be used for conduct of National Coaching Camps at this centre. Plan and estimates may be prepared for this purpose.</p>	Director (Infra.)/ In-charge, SAI Aurangabad Centre
(iv)	<p><u>Indoor Shooting Range:-</u></p> <p>Maharashtra has emerged as a hub for shooting sport. There is an ample land available at this centre, which can be utilized to develop a basic indoor shooting facility for 10, 25 & 50 Mtrs. Air Rifle and Air Pistol events. CPWD may be asked to prepare plan and estimates for taking up this project immediately.</p>	Director (Infra.)/ In-charge, SAI Aurangabad Centre
(v)	<p><u>Swimming Pool 50 Mtrs. (International standard)</u></p> <p>A swimming pool is essential for recovery and recreation of athletes at the centre. This facility could be used for conduct of National Coaching Camps as well as for community connect.</p> <p>CPWD has been requested to prepare preliminary estimates and the same is under process.</p>	Director (Infra.)/ In-charge, SAI Aurangabad Centre
