

**VISIT OF SHRI. INJETI SRINIVAS, IAS, DIRECTOR GENERAL, SPORTS AUTHORITY OF INDIA TO SAI  
LNCPE FROM 03.05.2016 TO 07.05.2016**

Arrival in Trivandrum on 03.05.2016 by Air India flight AI 048 at 10.45 p.m. Had a meeting with the Chief Secretary of Kerala, Shri.S.M.Vijayanand, IAS at 9.30 a.m. on 04.05.2016. The following issues were discussed in the meeting:


1. Waiving the rental charges of equipment hired for the conduct of SAF Games Guwahari from Government of Kerala.
2. Expediting the execution of official land transfer deed with University of Kerala for the 50 acres of land transferred for the establishment of LNCPE, Thiruvananthapuram.
3. Exploring the possibility of allotting additional land for the future development of SAI LNCPE.
4. Expediting the MOU with Govt Brennen College, Thalasserry for laying of Synthetic Athletic Track.
5. Expediting the facilities at Calicut University campus for the shifting of STC Calicut and also commencing the football academy.

2. At 10.30 a.m. inaugurated the Summer Coaching Camp - 2016 at SAI Thiruvananthapuram Golf Academy organized by the SAI Thiruvananthapuram Golf Academy. 75 campers have been enrolled in the disciplines of Tennis, Badminton, Health and Fitness, Yoga, Kalarpayattu etc.

3. At 12,00 Noon , M/s KITCO, a Govt of Kerala project Consultancy agency presented a plan for revamping of the Thiruvananthapuram Golf Academy with financial assistance from the Ministry of Tourism, Govt of India. The Director General, SAI observed that the project should be finalized in consultation with experts including IGU and Club Captain and submitted immediately with a time line of 30 days. There should be monitoring committee for the project implementation. The objectives of Club and Academy should be duly factored.

4. At 12.30 p.m., the Director General had a meeting with CPWD officials concerning the following core issues and directed the CPWD to take immediate action:

- a) Expediting the relaying of the defective synthetic track constructed at SAI LNCPE.



- b) Completing the work of laying Synthetic Track at Usha School of Athletics. The present status and targeted date of completion to be conveyed to SAI Head Office for the release of further funds.
- c) The CPWD is permitted to utilize the saving from the construction of the elite hostels at SAI LNCPE for construction of Dining hall to the hostel.

5. At 1.00 p.m., the Director General had discussions with the NPCC officials on the construction work at SAI SAG Alappuzha. The Director General expressed concern at the delay in executing the work. He instructed to complete the work within the time frame, i.e., before 31<sup>st</sup> July 2016. He also emphasized that the construction should be cost effective and durable.

6. At 2.30 p.m., the Director General had a discussion with Mrs. Anju Bobby George, President, Kerala State Sports Council. Mr. Bobby Aloysius, International athlete, coaches, officials on the functioning of the SAI Thiruvananthapuram Athletics (Jumps and Sprint) Academy. The following decisions were taken for the better operation of the scheme:

7. After lunch, the Director General had meeting with Wg.Commander Arun Kumar Singh, Director General, Indian Golf Union. Shri.Joseph Chackola, Golf expert and member, IGU, Shri.John Thomas, Captain of Thiruvananthapuram Golf Club and other stake holders on the functioning of SAI Thiruvananthapuram Golf Academy and Golf Club. The following are the major decisions:

- i) The Indian Golf Union (IGU) will be entrusted with the operation of various training programmes in Golf on the basis of a format MOA to be executed.
- ii) The IGU shall be responsible for the technical management of the Golf Academy.
- iii) The IGU shall appoint coaches and provide necessary equipment.
- iv) SAI will support with financial assistance
- v) It is proposed to have level I, II and III training programmes in association with the SAI Bangalore Golf Club.
- vi) Three weeks' camp shall be organized for talent hunt.
- vii) Foreign coaches shall be appointed.
- viii) The IGU shall arrange tournaments for required completion exposure.
- ix) There will be an Executive board and a steering committee to monitor the operation of training programmes.
- x) Three months timeline is drawn to complete all formalities and it has been decided to commence the scheme in July 2016.

8. At 6.00 p.m., the Director General reached SAI LNCPE campus and witnessed the flagging off the mass run by Ms.Manju Warler, famous Malayalam film actress. Ms.Anju Bobby George, President, Kerala State Sports Council, Shri.Loknath Behra, IPS, DGP was present on the occasion, Following the mass run a public function was arranged at the SAI LNCPE new stadium with a spectacular gathering of more than 1500 participants including the National campers, Summer campers, parents, STC/COE trainees, administrative staff, coaches, faculty, students of Refresher Course, NIS Internship trainees etc. The mas Yoga, Aerobics, Kalari demonstration by the participants added colour to the programme. The Director General, SAI congratulates the participants and parents for devoting their time for sports.

9. On 06.05.2016 at 10.00 a.m., Director General reached SAI LNCPE campus and had a meeting with the Principal, senior officers, British Council delegates, followed by a Gymnastic display and Volleyball exhibition match by SAI trainees. The following is the gist of discussions at the meeting and decisions taken.
