

## SPORTS AUTHORITY OF INDIA

### REPORT ON THE VISIT OF UNION SECRETARY (SPORTS) CUM-DIRECTOR GENERAL, SAI TO VIJAYAWADA ON 07<sup>TH</sup> DECEMBER, 2016

I attended a Stakeholders' conference organized by the Sports Authority of Andhra Pradesh (SAAP) to deliberate on the draft New Sports Policy formulated by them. Apart from Shri L.V. Subrahmanyam, Special Chief Secretary, Youth Affairs & Sports, Government of Andhra Pradesh and senior officials of SAAP, a number of stakeholders including the local Member of Parliament, Shri Ganga Raju (who is also General Secretary, Andhra Cricket Association), Commissioner of School Education, IGP, representatives of State Associations, eminent sportspersons, coaches and NGOs participated in the deliberations.

2. The draft policy is forward-looking and deals with both grassroots development and high performance sports in an effective manner. Some of the salient features of the policy include the following:-

- Sports & Physical Education has been made an integral part of school curriculum with minimum number of PT/ sports periods per week. Government order in this regard is placed at **Annexure-I**.
- Provision has been made for developing a playfield in every village by mobilizing funds from MGNREGA @ Rs. 5 lakh per playfield. It would be ideal if this could be replicated by all States so that we can have 7 lakh playfields covering each & every village in the country, which can also be institutionalized under National / State/ District Playing fields Associations. Further, other basic facilities such as toilets, drinking water facility, change room, fencing, etc., can easily be established through convergence with various national/ state programmes.
- The Government of AP has also sanctioned Rs. 2 crore per Assembly Constituency for setting up a sports complex called **Kreeda Vikas Kendra (KVK)** consisting of a minimum of 06 acres of land with indoor and outdoor playing facilities. Government order relating to KVK is placed at **Annexure-II**
- Community Coaching development
- System for talent identification and development with long-term athlete development programme.
- Setting up of Sports Schools and Regional Academies
- Incentives for sportspersons

3. The following suggestions given by SAI, have been duly incorporated in the policy:-

- (i) Making Sports and Physical Education an integral part of school curriculum may be stated explicitly along with minimum number of PT / sports periods per week.
- (ii) Once sports becomes a part of school curriculum, gifted & talented students can pursue dual pathway (academics and sports) which may make it necessary for having basic infrastructure and coaching facilities at school, college and university level as well.
- (iii) The concept of voluntary community coaching, using the services of sportspersons in schools and colleges (on the lines of NSS) may be explored.
- (iv) It may be useful to see whether the State would like to set up Sports Academies in selected disciplines.
- (v) Given there are multiple stakeholders in the field of sports, appropriate consultative forums at District and State level may be useful. The State level forum may be chaired by the Chief Minister. In order to ensure convergence within the Government other than Youth & Sports, Education, Urban Development, Rural Development, Women & Child Development and Health Departments should also be part of the high level forum set up at the State level.
- (vi) Linkages with Regional / National Institutions related to sports development.
- (vii) Identification of 3 to 4 disciplines in which the State would like to specialize for promotion of sports excellence.

In addition, to the above, the State Government was advised to add 'Clean Sports' as an objective to address the problems of doping and age fraud.

4. After the conference, I discussed with the Special Chief Secretary regarding issues related to 'Khelo India' and SAI schemes. The following issues require immediate attention: -

In the reference read above, the Commissioner and Director of School Education, A.P., Hyderabad has informed that every year School Education Department is issuing School Academic Calendar duly prescribing the number of periods in a day, school timings, subjects to be covered and other activities etc. As per the Academic scheduled all the classes from I to X have to follow prescribed number of periods every day. The number of periods are allocated on weekly basis to all subjects of all subjects of all classes.

2. The Commissioner and Director of School Education, A.P., Hyderabad has further informed that the School going children, parents are frequently requesting Government to increase the Physical Education Activities / Sports / Games in the schools. The Government after reviewing the matter decided to give priority to the Physical Education Activities / Sports / Games for all round development for achieving universalization of sports opportunities on systematic and scientific lines for each child from Classes I to X.

3. Therefore, the following time table / activities on each subjects per week is proposed for redesigning duly increasing the number of periods for Physical Education Activities for holistic development of children, fostering Physical and emotional health and for providing opportunities for play and self expression etc.

**ORDER:**

In the review meeting on sports held by Hon'ble C.M. on 27.10.2016 among other issues, guidelines for construction of Kreeda Vikasa Kendra in the State have been approved. These are attached as Annexure-I to this order.

2. In the meeting, it has also been decided to construct sports facility initially at a select centre in a Assembly Constituency which shall be called as '**KREEDA VIKASA KENDRA**' (KVK). Such a KVK with an estimated cost of Rs.200.00 lakhs shall be completed in a phased manner in all 175 constituencies in the State.
3. The VC&MD, SAAP in his letter 2<sup>nd</sup> read above has proposed to take up the construction of 57 Kreeda Vikasa Kendras in various Assembly Constituencies with a cost of Rs.102.96 Crores from the plan provision during 2016-17 and requested to accord administrative sanction.
4. The Govt. after careful examination of the proposal of VC&MD, SAAP, hereby accord administrative sanction to incur an expenditure not exceeding Rs.78.00 Crores (Rupees Seventy Eight Crores only) towards construction of new KVKs and complete the ongoing play facilities taken up during 2016-17, subject to meeting the expenditure as per requirement.
5. The expenditure sanctioned above shall be debited to the following Head of Account.

6. The VC&MD, SAAP shall adhere to the guidelines scrupulously issued on construction of KVKs while taking up construction of Kreeda Vikasa Kendras which are appended as at Annexure - I. He shall take into consideration the Model Estimates Prepared on based on SSR Rates 2015-16 which are appended as Annexure-II to this order. He shall utilize the funds provided under SCP and TSP in the construction of KVKs duly following the instructions / orders issued on utilization of the funds in the respective plans wherever stated by those departments. The entrustment of works by District Collectors shall be fool-proof and should be based on the established procedure of the Govt. The utilization certificates for the expenditure incurred on construction /completion of each stadium should be submitted immediately by District Collectors after completion of the respective work. They may note that play-fields can be developed immediately while engineering of indoor facility is underway.

**GUIDELINES ON CONSTRUCTION OF "KREEDA VIKASA KENDRA" IN THE STATE**

1. In all Assembly Constituencies, Kreedha Vikasa Kendra's are proposed in each Assembly Constituency.
2. Priority is given to the lands available in Schools or Colleges of that Mandal. The land available should be of minimum of Ac. 6.00 of land so as to convert the land into a Green Field Stadium.
3. Kreedha Vikasa Kendra will be sanctioned based on the feasibility conditions and accessibility to the public, youth, High school and Jr. College students.
4. Feasibility report will be prepared by a Team consists of the Coaches working in District Sports Authority, District Sports Development Officer and Joint Collector of the District.
5. If the Kreedha Vikasa Kendra is proposed in a School or College Grounds, the authorities of concerned should submit a NO OBJECTION CERTIFICATE to the District Sports Authority concerned stating that they have "NO OBJECTION" to utilise the facilities by the local youth and other schools children.
6. The District Collector will identify the Executing Agency and alienate the land in favour of District Sports Authority.
7. Once the land is alienated and NOC is received from the DSA, the SAAP will prepare the DPRs, Designs and Estimates with the consultant Architects with SSR Rates of 2016-17 and forward to the District Collector.
8. Period of completion of Stadium will be six (6) months.
9. Preference shall be given for creation of play fields with proper fencing with barbed wire rather than construction of a Compound wall.
10. After construction of pavilion building, barbed wire fencing around the allotted land, Shopping Complex should be planned and constructed.
11. Playing facilities like Tennis, Shooting and Bowling etc., should not be created.
12. Three (3) rows of trees should be planted around the barbed wire fencing.
13. Electricity, Water, Drainage, Security and a room for security should be arranged before taking up construction of Kreedha Vikasa Kendra.
14. The Stadium shall have a Septic Tank in a suitable place that has access to a four wheeler reach.
15. The District Collector shall collect the reports on the constructions and take appropriate action for completion within six (6) months.
16. The DSDO shall be responsible for proper creation of playing facilities and to follow the prescribed designs as per the DPR sent by SAAP in the construction of Kreedha Vikasa Kendra.
17. DSA shall have freedom to go for extra facilities other than the facilities mentioned in the designs, if funds are locally mobilised form MPLADs/MLAs/MLCs or from philanthropists.
18. The Project Cost is restricted to Rs. 2.00 cores only.
19. District Collector shall constitute a Committee to each Stadium like Mandal Sports Authority for its maintenance with local PET/PD/Sportsman / Municipal Commissioner / Sarpanch / Philanthropists.
20. The SAAP/DSA shall fix the entry fee / user fee.
21. Pay and Play scheme should be introduced in every stadium.
22. DSA shall provide sports material from the maintenance grant

25. The District Collectors to match MGNREGS funds under labour component in case of short fall of funds over and above the cost of Rs. 2.00 Crs. for construction of Kreedha Vikasa Kendra whenever necessary.
26. Growth centres of the local areas where the stadium is located shall be made involved in the maintenance of play fields after completion of the construction of stadium.

**Guidelines for creation of playing facilities in indoor stadia:**

1. Every indoor stadium should have at least two shuttle badminton courts with wooden flooring. So also one Volleyball and if possible one or two rings for Boxing and one Basketball can come up. Flooring must be designed keeping this multi-disciplinary demand in mind.
2. KIRBI type lightweight roofing are any day preferable to cement concrete roofs and walls which are prone to civil engineering mistakes / shortcomings.
3. The Committee constituted for the Kreedha Vikasa Kendra is responsible for conducting periodical tournaments / competitions once in every three months form out of the funds of maintenance grant available.
4. Entry / User Fee shall be collected for Indoor Stadium and credited to the Stadium account.
5. Minimum staff like Coaches, Security, Groundsmen and Sweepers to provide coaching and for maintenance of play fields shall be engaged by the Committee so constituted for the Kreedha Vikasa Kendra from out of the maintenance grants of the Stadium.
6. Required Sports equipment shall be provided by the Stadium Committee.

**GENERAL**

1. SAAP will issue proceedings for release of funds to the Executing Agency / Contractor to the extent of value of work done through PAO, as per the recommendations of the District Collector.
2. Rs. 5.00 lakhs should be kept separately from out of the construction grant for future maintenance and purchase of sports equipment.
3. The District Sports Authority should approach for funds from National Sports Development Fund (NSDF) / Corporate Social Responsibility (CSR) funds from Corporate Bodies, Banks, Public Sector Undertakings as per their promise on 01.07.2016 before the standing Committee on Parliamentary Affairs on HRD in Visakhapatnam.
4. Walkers track should be arranged around the Kreedha Vikasa Kendra and collect fee from Walkers duly giving them identity cards.
5. Change Rooms should be arranged separately for boys and girls with toilets.
