Tender for supply of Gym Equipment to Regional Centre, SAI, Kandivali (E), (Mumbai)

1. **Earnest money amounting 2% of the estimated value** in the form of Demand Draft issued by Bank in favour of Director, Regional Centre, Kandivali (E), Mumbai, Duly signed Tender Document along with relevant/requisitioned documents shall be submitted (Technical Bid) in Envelope 'A'.
2. The **Financial bid** is submitted in **Envelope 'B'**.
3. Both the bids should be submitted in an envelope on which the words **supply of Gym equipment** should be super scribed on the top of the left corner of the envelope which should also so the name and address of the bidder.
4. The total turnover of the tenderer shall be Rs. 15 Lakhs for the last three preceding years.
5. Bidders are required to quote for only one of its best & economical brand of an item.
6. The quantity and size of each item will be decided by the Director, Regional Centre, Kandivali (E), Mumbai.
7. In case of doubt in material the expenditure on testing of materials will be borne by the tendered.
8. 10% interest **free security money shall be deducted from the bill of the** successful bidder, which will be refunded after 3 months from date of supply.
9. EMD to the successful bidder will be refunded after finalization of the contract and of successful bidder on computation of supply of material.
10. Competitive rates should be **inclusive all taxes destination i.e. Director, Regional Centre, SAI, Kandivali (E), Mumbai** quoted in the tender should be valid of one year from the date of acceptance of bid.
11. Items quoted by the firms should be strictly as per specifications/rate quoted in Financial Bids.
12. The supplies shall be executed at the time and in the manner prescribed by the indenting officer. Any contravention thereof shall be deemed as a breach of supply and penalties as prescribed by the Director, Regional Centre, SAI, Kandivali (E), Mumbai may be imposed.
13. The Director, SAI, Kandivali will have the right to reject any or all the bids without assigning any reason. Bids received without the earnest money, conditional or incomplete having cuttings or overwriting is liable to be rejected.
14. The supplies received, if not found as per specification of tendered items are liable to be rejected.
15. In case the bidder fails in making the supply in a given time and place the institute shall have the right to purchase the same from the other sources at the risk and cost of supplier.
16. Director, Regional Centre, SAI, Mumbai will be legally competent to cancel the contract of supply and also to take any other action against the supplier including imposing of any penalty on the supplier during pendency and till the final execution of the contract of the supply, in case the supplier is ever found to have committed any fraud against Regional Centre, Kandivali (E), Mumbai in supplying the material or indulge in any other malpractice's thereof causing any financial losses during contract period.
17. The contract can be terminated or cancelled summarily by SAI in whole or in part any time without assigning any reason, if the supply made by the manufacturer/supplier is not found according to the sample approved or in case supply is not received within stipulated time.

18. The Director, Regional Centre, Mumbai have right of awarding the work to one supplier or different suppliers for the supply of Gym Equipment.
19. The Director, Regional Centre, SAI, Kandivali (E), Mumbai will have right to forfeit the earnest money, if the terms & condition of the agreement are not adhered to by the supplier/breach of contract.
20. In case any dispute arises in regard to the tender, the decision of the Director, Regional Centre, SAI, Kandivali (E), Mumbai will be final and binding.
21. In case of short supply and faulty materials not complying, the competent authority may impose a penalty of 10 per cent on total amount.
22. In case of litigation, the courts at Mumbai only will have jurisdiction for deciding case according to Indian law in force.
23. The technical bid of the bidders will be opened first and the financial bid will be opened only of the bidders whose Technical bid will be accepted by the competent authority.
24. These are only proposed draft Terms & Condition and can be modified changed or added to at the time of finally concluding.
