Sub: ADMINISTRATIVE SANCTION FOR SELECTION TRIALS.

Administrative approval of the Competent Authority is hereby accorded to conduct open selection trials at IGS, Delhi from 27th to 30th December, 2016 to select core probable's (Male & Female) in Artistic Gymnasts for national coaching camps and future International competitions as per detail given below:

- i. The Secretary General India Olympics Association (IOA) is requested to inform all state Olympic Associations and its state units to send their Representatives and best eligible gymnasts (Men & women in Jr. & Sr. categories) for the open selection trials scheduled at IG sports complex, New Delhi from 27th to 30th Dec. 2016, at no cost to SAI/Govt.
- ii. The President/ Secretary, GFI (De-Recognised by MYA&S) is also requested to inform their state gymnastics associations to send their eligible gymnasts (male & female) for the above mentioned selection trials.
- iii. The President/ Secretary, GFI (De-Recognised by MYA&S) is requested to depute qualified Judges International/National for evaluating the performance of participating gymnasts during the selection trial.
- iv. The judges will be entitled for TA /DA as per camp norms i.e. travel By 2nd AC train by shortest route for to and fro journey including taxi fare from residence to nearest railway station at both the places while departure and arrival.
- v. Free boarding and lodging will be provided to all deputed judges of GFI at IGS/JNS Hostels as per camp norms applicable to senior category other than food supplements from 25th to 31st December, 2016.
- vi. The selection trials will be covered under video coverage for fair and transparent selection.
- vii. Hiring of 03 Videographers with Video cameras for recording the complete selection trials on payment from 27th to 30th Dec. 2016 as per the selection trials schedule prepared by Dr. G.S. Bawa. Chief Coach Gymnastics.
- viii. Dr. G.S. Bawa, Chief Coach with eminent sports persons & coaches – Arjuna Awardee or Dronacharya Awardee along with the Secretary General, IOA and President / Secretary Generals of GFI or their Authorised (with letter) representative will be the members of the selection committee under the Chairmanships of Executive Director TEAMS, SAI and PO, TEAMS (Gymnastics) as convenor.
- ix. All the participating Gymnasts, Coaches and Judges are requested to bring their latest passport size photographs (03 Photos) for registration purpose.
- x. Participants and their coaches / guardians are not entitled for any TA- DA or boarding and lodging from SAI to attend the above mentioned selection trails.
- xi. All the gymnasts (male & female) appearing in the selection trials must carry their latest fitness certificate from the authorised doctor.

- xii. Dr. Subroto Mallick, SO (SM) is requested to make necessary arrangements for complete medical support (Ambulance, First aid etc.) during the selection trials scheduled from 27th to 30th Dec. 2016 from Morning 9 AM to 8. PM.
