Sub: - Engagement of Young Professionals on contract basis.

Sports Authority of India (SAI), an autonomous organization under the Ministry of Youth Affairs and Sports, Government of India invites applications for engagement of Young Professionals on contract basis initially for a period of one year extendable up to a maximum of three years for support in Administration, Finance, Sports Management, Law, General Management & Engineering.

All existing Young Professionals of SAI are also required to apply in the prescribed format as per the advertisement.

1. **Requirement:-**

2. Job Description and other requirements are given in **Annexure – I**.

3. Terms and Conditions of engagement of Young Professionals shall be as under:-

- a) **Tenure:** - The contractual engagement will be initially for a period of one year which could be further extended for a maximum period of three years.
- b) **Age Limit:** - The maximum age shall not be more than 35 years on the last date of receipt of applications.
- c) **Remuneration:** - Fixed Monthly remuneration of Rs. 45,000/- for fresh Graduates and up to Rs. 60,000/- for others as per the experience and qualifications as recommended by the designated committee.
- d) **Tax Deduction at source:** - The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the SAI will issue TDS Certificates/Service Tax, as applicable.

Other Allowances: - No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance /Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible to them.

e) **Extension:** - Performance of the Young Professional would be continuously reviewed and their extension will be considered on the basis of periodic review / requirement.

f) **Leave:** - They will be entitled for 30 days leave in a calendar year on pro-rata basis. Therefore, Young Professional shall not draw any remuneration in case of his/her absence beyond 30 days in a year. Also un-availed leave in a calendar year will lapse and will not be carried forward to the next calendar year.

g) Confidentiality: -

- i. Young Professionals may not, except with the previous sanction of Sports Authority of India in the bonafide discharge of his/her duties, publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or anonymously or pseudonymous in the name of any other person, if such book, article, broadcast, uses any information that he/she may gather as part of this assignment.
- ii. During the period of engagement with Sports Authority of India, the Young Professional would be subject to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by his/her during the period of his/her engagement to anyone who is not authorized to know.
- iii. The Young Professional engaged by the Sports Authority of India shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of Sports Authority of India.

h) Other Conditions: -

- i. The applications received will be scrutinized and eligible candidates will be called for Interview at cost to the applicant.
 - ii. In case they are required to precede outstation from their place of posting on tour for official duty, they will be entitled to TA/DA as admissible under the rules as applicable to Officers of the level of Assistant Director in SAI.
 - iii. In case performance of any Young Professional is not found up to the mark, their services will be discontinued after giving one month notice.
 - iv. Sports Authority India may withdraw offer at any time without assigning any reason.
 - v. The DG SAI shall be the final authority in case of any issue arising out of this contract.
 - vi. This appointment will be on contract basis and does not confer any right to claim to permanent employment in SAI.
4. Sports Authority of India reserves the right to terminate the contract, by giving thirty days notice to any Young Professional.

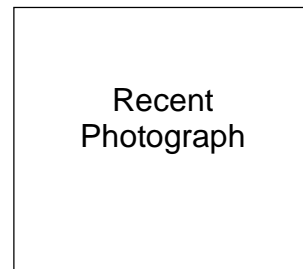
