- v. The judges will be entitled for TA/DA as per camp norms of junior category i.e. travel by 2<sup>cd</sup> AC train by shortest route for to and fro journey including taxi fare from residence to nearest railway station at both the places while departure and arrival.
- v. Free boarding and lodging will be provided to all deputed judges of GFI at IGS/JNS Hostels as pér camp norms applicable to senior category i.e. @ Rs.690/- & @ Rs.1500/- per day for lodging from 15<sup>th</sup> to 17<sup>th</sup> September,2019.
- vi. The selection trials will be covered under video coverage for fair and transparent selection.
- vii. Hiring of 03 Videographers with Video cameras for recording the complete selection trials on payment from 16<sup>th</sup> Sept, 2019 as per the selection trials schedule prepared by Dr.G.S. Bawa. Coordinator, National Coaching Camp in consultation with the other coaches of the camp.
- viii. All the participating Gymnasts, Coaches and Judges are requested to bring their latest passport size photographs 03 Photos) for registration purpose.
