- The President/Secretary general, GFI (Not recognized by the MYAS & IOA) is requested to depute qualified judges National/International with the consultation of undersigned to evaluate the performance of gymnasts during trial. V.
- Free Boarding & Lodging will be provided to all invited Judges/Officials at IGSC/JNS Hostels as per Jr. National Coaching Camp norms from 28 Sept. to 01 Oct. 2018.
- The Judges/Officials will be entitled for TA/DA as per camp norms i.e. travel by 2nd AC Vi. train /AC Bus by shortest route for to and fro journey including local journey charges. vii.
- Hiring of Videographers with video cameras on payment from 29 to 30 September, 2018 for recording the complete selection trial for fair and transparent selection process . viii.
- Selection committee under the Chairmanship of Regional Director (TEAMS) SAI, consist with eminent Sportsperson & Coaches (Arjuna or Dronacharya Awardee) along with Authorized representative (with letter)from IOA and GFI as a members and PO (TEAMS-Gymnastics) SAI will be a convener.
- Dr. Subroto Mallick, SO (SM)is requested to make necessary arrangement for the ix. complete medical support (Ambulance, first Aid etc.) during selection trials from 29 to 30 September, 2018 from 8.30 AM to 8 PM at IGSC Delhi. X.
