- 30. In case of delay in supply by the stipulated date, Asstt. Director, SAT Training Centre, NRC, Sonepat reserves the right of imposing penalty as deemed fit.
- 31. Sales Tax/VAT and transportation charges as applicable will be paid extra and no other charges /Levi shall be paid.
- 32. Payment will be released after satisfactory supply and receipt of goods, supplied as per supply order.
- 33. The manufacturer/supplier should be able to give minimum guarantee of six months for material manufacturing defects, and undertake to replace defective products at no extra cost within a month of the defect being brought to notice of the manufacturer/supplier.
