
TERMS & CONDITIONS

- 1. The contractual engagement will be initially for a period of one year which could be further extended based on the performance/review reports.
- 2. Number of post may increase/decrease depending upon the requirements.
- 3. The appointee shall perform the duties assigned to them by the superior officers. They may be assigned any additional duties, as and when required. No extra remuneration/allowances will be paid for additional assignment.
- 4. Appointee will not be allowed private practice during the contractual period.
