## **TERMS & CONDITIONS**

- 1. The appointment is purely on contract basis initially for a period of twelve months or till regular recruitment is done, whichever is earlier.
- 2. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in the SAI OR for continued contractual appointment which may be renewed or terminated on the basis of satisfactory performance and conduct.
- 3. The contract will entitle the contractual appointee at a consolidate remuneration of Rs.36,120/- per month. The contractual appointee will not be entitled to any other allowances.
- 4. The contract will automatically expire on completion of twelve months until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time, by either side, by giving 30 days notice or salary in lieu thereof.
- 5. The leave entitlement of the contractual appointee shall be governed in terms of instructions contained in DOP&T OM No.12016/3/84- Estt.(L) dated 12.4.1985 as amended from time to time.
- 6. The Competent Authority reserves the right to withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- 7. Only Indian Nationals are eligible to attend Interview.
- 8. Upper age limit is 45 years on the date of walk in interview which is relaxable for SC/ST & OBC candidates and Govt. Servant, as per rules.
- 9. Retired Medical Officer (Military/Defence Services) may also apply.
- 10. This contractual appointment is whole time and private practice of any kind is prohibited.
- 11. He/She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.
- 12. No travelling or other allowances will be paid to the candidate for Interview and joining the post.
