- 1. The above candidates will get consolidated remuneration of Rs. 1,05,000/- per month.
- 2. The initial appointment is for 1 year further extendable for 3 years subjected to yearly performance review.
- 3. They will perform the duty of coach 06 days a week as per schedule of the Centre (Sunday or any other day according to schedule of the concerned centre being a holiday for coaching / training)
- 4. They will be entitled for leave of 2.5 days in the month (30 days leave in a calendar year) on pro-rata basis, which is liable to be lapsed, if accumulated at the end of tenure.
- 5. After completion of document verification, the candidate shall have to proceed directly to their respective place of posting with TA/DA and if they may be required to proceed outside their place of posting on tour for official duty. In such a case, they will be entitled to TA/DA, as admissible under the Rules to regular Assistant Coach of SAI.

- 6. They will not be entitled to any other kind of facilities like re-imbursement of Medical Expenses, Leave Travel Concession (LTC) etc.
- 7. Their engagement with SAI can be terminated after giving one month's notice from either side.
- 8. During the period of contract with SAI, their work/ performance would be under observation. If their performance is not found as per the requirement/to the satisfaction of superiors, their contract will be terminated with immediate effect.
- 9. They may be asked to perform specific acts and duties and they shall discharge them with full satisfaction of the supervising officer.
- 10. Their posting is specifically to the designated place mentioned above and no request for transfer on any ground will be entertained. However, SAI reserves the right to utilize their services at any of its Scheme/Academics institution during the period of contract.
- 11. No request for extension of date of joining will be entertained rather it will be treated as his/her unwillingness to join and this offer will be deemed as cancelled.
- 12. Legal dispute /grievances, if any, due to the contractual appointment will be dealt under the jurisdiction of courts of law in Delhi only.

If the above terms & conditions are acceptable, you may report to SAI, Regional Centre / SAI office as mentioned above on 01.01.2022 and not later than 10.01.2022 failing which this offer will be treated as cancelled without any further correspondence and claim.
