

The Prebid queries received from prospective bidders and the reply to the same is attached below for information.

1.	Please let us know the <b>Start date and End date</b> for conducting the 180 episodes. From when do we need to start conducting the first episode? This way we will be already working towards the possibility of a customised App development if we have the requisite time.	The bidder/agency shall be provided with the list of shortlisted schools after the Preliminary round by November 30, 2021 and the state rounds will be tentatively from Dec 15, 2021 to Jan 15, 2022.
2.	Can we use the <b>Zoom/Google meet platform</b> for conducting the Quiz? Later we can edit the raw content in Postproduction and hand it over. Is this possible?	Yes, bidder can integrate Zoom/Google Meet, however the bidder has to ensure the that the elements mentioned under the scope of services on Page 26 of the RFP without fail in their platform.
3.	Do you have the <b>Copyrights for the Audio Visuals</b> as most content is downloaded from YouTube/Google etc and later we may have to face copyright issues?	The bidder will be responsible for purchasing the copyrights for multimedia used in the formation of questions, wherever required.
4.	What do we do to overcome the <b>internet connectivity issue</b> in remote locations where there is no proper internet connectivity?	The bidder is expected to include such issues in their contingency planning while proposing the execution plan. The bidder is expected to conduct tech check with each participant for ensuring compatibility as per requirements
5.	We are MSME registered, so 2 Lacs EMD will be exempted for us. We will submit proof of the same in Technical bid	Yes. Subjected to submission of relevant supporting document. Also, the bidder will have to submit the Bid Security Declarations in the format attached in Annexure 2 if availing the exemption. For further clarification- the information against EMD on CPP portal is mentioned as 'Nil', however the bidders need to refer the RFP document for EMD related instructions.
