Subject: Recruitment of Guest Faculty for Lakshmibai National College of Physical Education, Thiruvananthapuram — regarding

The Lakshmibai National College of Physical Education (LNCPE), Thiruvananthapuram is the academic wing of the Sports Authority of India (SAI). The College is affiliated to University of Kerala and it aims to serve as a model institute for teacher training by offering undergraduate and post-graduate courses. SAI-LNCPE also offers PhD course (a research centre under University of Kerala) besides both regular Post Graduate Degree course (MPES) and Teachers Education course (BPEd) in Physical Education under the University of Kerala.

Applications are invited from the eligible candidates for engagement as Guest Faculty in Physical Education for the academic year 2022-23 at Lakshmibai National College of Physical Education for teaching Physical Education Courses.

General Instructions/Information

1. The mere fact that a candidate possesses the qualification will not entitle him/her for selection. Applicant having higher qualification and merit and possessing qualification and experience required for specific sports will be given preference
2. Suppression of factual information, supply of fake document, providing false or misleading information or any other undesirable action by the candidate shall lead to cancellation of his/her candidature.
3. Any change of address given in the application form should at one be communicated.
4. The candidate will have to present himself/herself for interview at the place and time mentioned, at his/her own expenses.
5. Canvassing in any form on behalf of any candidate will disqualify such candidate.
6. Selection will be made on the basis of candidate's previous records and performance in the interview
7. Applications incomplete in any respect will not receive any consideration at all
8. Guidelines to the candidates, who are already employed in Government Organisations /PSUs, Autonomous Bodies: The candidates employed in Government Organisation/PSUs, Autonomous bodies should bring their application along with relevant documents and endorsement of the employer through their offices.
9. No Interim Queries regarding selection will be entertained.
10. The institution reserves the right :
 - i. To with draw the advertisement either partly or wholly at any time without assigning any reason to this effect
 - ii. To fill or not fill up some or all the posts advertised for any reason whatsoever.
 - iii. Number of posts advertised may be treated as tentative. The SAI LNCPE has the right to increase/decrease the number of posts at the time of selection and make appointments accordingly.
 - iv. To decide criteria/procedure for short listing of the candidates

- v. To relax any of the qualifications, experience, age, etc., its exceptionally deserving case of all posts on the recommendations of the Selection Committee.
 - vi. The selection committee may decide its own method of evaluating the performance of the candidates in interview.
11. The Institution will not be responsible for any postal delay at any stage
 12. In case of any dispute/suites or legal proceedings against the Institution, the Jurisdiction shall be restricted to the High Court of Kerala
 13. The Institution shall verify the documents submitted by a candidate at any time at the time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has clandestine antecedents/background and has suppressed the said information, then his services shall be terminated.
 14. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the Institution reserves the right to modify/withdraw/cancel any communication made to the candidates
 15. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the Institution shall be final.
 16. All certificates, which are not in either English or Hindi, need to be translated preferably to either English or Hindi and the same shall be self-attested.
 17. The selected candidates shall be required to work in LNCPE, Thiruvananthapuram
