Role: The Indian Weightlifting Federation (IWLF) invites online application for the role of <u>Head Physiotherapist</u>.

About Us: The Indian Weightlifting Federation (IWLF) is the National Sports Federation for the sport of Weightlifting in India, recognised by the Department of Sports, Ministry of Youth Affairs & Sports, Government of India, and International Weightlifting Federation (IWF) and affiliated to Indian Olympic Association.

Purpose of recruitment: The Indian Weightlifting Federation is looking for a senior physiotherapist to head its injury prevention and rehabilitation programmes. The <u>Head</u> <u>Physiotherapist</u> will be expected to work with the Weightlifters in the National Coaching Camp as per directions of the National Coach. He/She will also be expected to manage, monitor and guide the other physiotherapists in the National Coaching Camp.

Place of Posting: The Head Physiotherapist, so recruited, will be posted in Patiala but may be required to travel extensively throughout the country and abroad.

Remuneration: INR 1,00,000 – 2,00,000 per month (depending on qualification, experience and overall performance of the candidate during the selection process)

HEAD PHYSIOTHERAPIST

Eligibility Criteria:

- 1. Post Graduation in Sports Physiotherapy i.e., MPT (Sports) or MPT (Ortho & Sports Combined PG degree) or equivalent qualification from a recognised university/institute.
- 2. No online degree/diploma will be accepted as substitute to above qualification
- 3. More than 7 years experience in sports such as Cricket/Olympic bound games at elite level preferably with national teams.
- 4. Other qualifications relevant to meet the sports specific demand may be considered as additional qualifications.

Job Description:

- 1. Oversee rehabilitation programs of all athletes.
- 2. Manage all designated Physiotherapists working with the team.
- Organize, develop and implement a comprehensive movement screening assessment for all first team players and, based upon the movement assessment findings, provide physical improvement stretch and strengthening exercises.
- 4. Shall be responsible for day-to-day injury management and rehabilitation of athletes.
- 5. Shall work on injury prevention strategy for the athletes in consultation with team doctor
- 6. Shall maintain a record of present and past injuries for all athletes of camp
- 7. Shall help the coach in planning and lead rehabilitation sessions for all athletes.
- 8. Any other work as assigned by IWLF/SAI.

- 7. Any experience claimed during the course of completion of the degree will not be counted. Any experience which is not relevant to the above discipline /fields will not be counted.
- 8. Candidates will be called for the interview based on the short listing criteria as mentioned above. Hence mere fulfillment of eligibility criteria does not entail that candidate will be called for the interview.
- 9. The Candidates should note that their candidature at all the stages will be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage before or after Interview, it is found that they do not fulfill any of the eligibility conditions; their candidature will be cancelled by the IWLF.
- 10. NOTE: SELECTED CANDIDATES WILL BE REQUIRED TO PRODUCE THE ORIGINALS OF THE CERTIFICATES MENTIONED ABOVE AT THE TIME OF JOINING. FAILURE TO SUBMIT THE REQUIRED CERTIFICATES IN ORIGINAL AT THE TIME OF PHYSICAL JOINING WILL LEAD TO CANCELLATION OF CANDIDATURE.

11. Terms & Conditions for contractual engagement:

- (i) **Tenure:** Initial contractual engagement will be for a period of two years. The tenure can be further extended on the basis of satisfactory performance and subject to requirement.
- (ii) Age limit: The candidate must not have attained 60 years of age as on the closing date of advertisement.

The date of birth, accepted by the IWLF is that entered in the Matriculation or Secondary School Leaving Certificate or in a certificate recognized by an Indian University as equivalent b Matriculation or in an extract from a Register of Matriculates maintained by a University which extract must be certified by the proper authority of the University or in the Higher Secondary or an equivalent examination certificate. Aadhar Card/Passport/Voter Id will also be accepted. No other document relating to age like horoscopes, affidavits, birth extracts from Municipal Corporation, Service records and the like will be accepted. The expression Matriculation/Higher Secondary Examination Certificate in this part of the Instruction includes the alternative certificates mentioned above.

Annual Increment upto 10% (maximum) may be considered subject to satisfactoryperformance.

- (iii) Tax Deduction at source: The income tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the IWLF will issue TDS certificates/ Service Tax, as applicable.
- (iv) Other Allowances: No TA /DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance/Transport, Personal Staff, Medical reimbursement, HRA, and LTC etc. would be admissible to them. In case he/she is required to proceed outstation from the place of posting for official duty, he/she will be entitled to boarding lodging and travel as per IWLF norms.
- (v) Extension: Performance of the selected candidates would be continuously reviewed and their extension will be considered on the basis of periodic review /requirements.
- (vi) Leave: Personnel will be entitled for 30 days leave in a calendar year on pro- rata basis. Employee shall not draw any remuneration in case of his/her absence beyond 30 days in a year. Also any un-availed leave in a calendar year will lapse and will not be carried forward to the next calendar year.

- (vii) **Termination**:- The contract can be terminated by giving a 30 days' Notice period by either party, ie. IWLF and the employee. In cases of extreme impropriety by the employee the contract may be terminated immediately without notice.
- **12.** Candidates must apply within the scheduled time period, no application received after the last date shall be entertained.
- **13.** Candidates who apply under this advertisement may also be shortlisted for future requirements of Support Staff in organisations covered under IWLF schemes.
- 14. Decision of IWLF in all matters regarding eligibility, selection and posting would be final and binding on all candidates. No representation or correspondence will be entertained by IWLF in this regard.
- 15. IWLF reserves the right to modify/alter/restrict/enlarge/cancel the recruitment process, if need so arises without issuing any further notice or assigning any further notice/any reasons thereafter. The decision of the IWLF will be final and no appeal will be entertained against this issue. A panel of eligible candidates will be created to cater to future requirements. The panel made by IWLF can also be utilized by various other Govt. Organization which are supported under various schemes of IWLF.
