- (ii) The list of eligible shortlisted candidates for interview along with date(s) and place of interview will be posted on IWLF website / through email(s).
- (iii) The Candidates should note that their candidature at all the stages shall be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage before or after Interview, it is found that they do not fulfill any of the eligibility conditions; their candidature shall be cancelled by the IWLF.

- 7. A panel of Coaches on contract shall be drawn and that will be valid for a period upto two years. The services of coaches kept in the waiting list may be utilized by Khelo India or any other scheme of SAI / Centre / State Government, if required.
- 8. The engagement of coaches on contract basis shall not confer on them any right for absorption or appointment on regular basis in IWLF.
- 9. The Sportspersons (Ex- International Athletes) inducted under contract as Coach will be required to devote full time to coaching and hence, it is advisable that only those sportspersons, who can devote full time for coaching should apply. They may have to undergo various short term / medium term training / orientation programme.
