2. **Extension:** The performance of the selected candidates would be continuously reviewed, and their extension will be considered on the basis of periodic review/requirement. **A remuneration 7% increment will also depend on the periodic performance review after the completion of 01 year of service in SAI, subject to satisfactory performance and recommendation of Reporting Officer.** In case a candidate's initial remuneration is fixed at the maximum salary of the pay range as mentioned, Rs. 70,000/- for YP, the same shall be frozen for an initial period of 02 years.
