Agenda Item 3: Opening of District wise Khelo India Centers (KICs) States of Madhya Pradesh, Meghalaya, Nagaland and Sikkim:

DPAC vide its meeting dated 04.06.2020 decided to establish 1,000 Khelo India Centres over a period of 4 years with a maximum of 01 per district (except for district in the North-east state, J&K, A&N Island, Lakshadweep and Ladakh, where there would be 2 KIC per district). In this regard, proposals were invited from State sports department for KICs in the prescribed format. The proposals from the following States/UTs are received as per the guidelines. Duly constituted committee verified the proposal and consolidated list of proposal received so far is given below.

The proposal was placed before the PAC held on 05.03.2021 wherein it was recommended to place the same before the next DPAC.

The approval of DPAC is sought for opening 36 KIC as per detail given below

- (i) Madhya Pradesh 06 centres with an expenditure of Rs. 30.00 lakhs recurring and Rs.30.00 lakhs non-recurring expenditure.
- (ii) Meghalaya- 18 centres with an expenditure of Rs. 90.00 lakhs recurring and Rs.90.00 lakhs non-recurring expenditure.
- (iii) Nagaland- 05 centres with an expenditure of Rs. 25.00 lakhs recurring and Rs.25.00 lakhs non-recurring expenditure.
- (iv) Sikkim 07 centres with an expenditure of Rs. 35.00 lakhs recurring and Rs.35.00 lakhs non-recurring expenditure.

The budget estimate for annual recurring expenditure is Rs. 1.80 Cr. and one-time grant is Rs. 1.80 cr for these 36 KICs for the approval of DPAC under the vertical 'State Level Khelo India Centre'







Agenda Item No. 4: Adoption of academies/Training Centre under "Gradation and Incentivization of Academies" for Cycling discipline

The Gazette Notification of Khelo India scheme, published on 16th October 2017, made provision of supporting talented athletes and the academies where they are training under the verticals "Talent Search and Development" & "Support to National/ Regional & State Academies". It also mandates the evolution of system for rating of the academy. For the structured implementation of the aforementioned verticals, a mechanism of accreditation of the academies was devised and the same is being implemented.

- 2. There are many small to large private training centres (academies) which train the athletes who subsequently migrate to accredited academies. Such incubation centres are working on their own to create talent pool at the grassroot level. Even accredited academies who do not have sufficient athletes under KITD are not provided any financial support under Khelo India, despite having invested in the infrastructure, human resources etc. Hence, it is proposed to implement an incentivisation model for all private academies/clubs (Govt. / PSU/ Khelo India accredited academies included) to encourage them to continue/ improve the level of training they provide.
- 3. In view of the above and in order to channelize the existing infrastructure implementation of an incentivisation model for all private academies (including Government/ Public Sector Undertakings/ Khelo India accredited academies) was approved in principle by the Departmental Project Approval Committee (DPAC) in its meeting held on 06th November 2020 to encourage them to continue and improve the level of training they provide.
- 4. DPAC further decided that 500 academies will be supported in total in 14 priority disciplines identified for excellence in 2028 Olympics (namely Archery, Athletics, Badminton, Boxing, Cycling, Fencing, Hockey, Judo, Rowing, Swimming, Shooting, Table Tennis, Wrestling and Weightlifting) over the next 4 years. It was also decided that the number of academies and quantum of funding under each discipline will be determined by an objective evaluation of the need for investment and each NSF's capabilities to leverage the incentivisation model and promote excellence in Olympics in their respective discipline.
- 5. Against the same, Cycling Federation of India (CFI) has forwarded the Detailed Project Reports (DPR) submitted by the respective centres in the prescribed format after duly examining the same. It was found that the centres were primarily divided between 2 different categories, i.e. Track and Road.

- 7. The proposal from CFI has been examined and it was noted that the need of the hour is to mobilize the various training centres and develop them as Feeding Centres for the National Centres of Excellence. It is pertinent to mention that there are currently almost 13 Velodromes across the country which are either owned by the universities or by various state sports departments. Out of these existing 13, atleast 7 of them are not functioning to their potential or are underutilized. Similarly, in case of Road or Mountain Bike (MTB) event training facilities, there is underutilization. Cycling is one of the priority Olympic discipline and in order to achieve excellence it is imperative to involve all stakeholders and existing facilities (Track, Road & MTB event).
- 8. In this regard, **the following model/guidelines are proposed** for each academy/training centre to be adopted under the Gradation and Incentivisation of academies model.
 - Each centre to be designated as Khelo India Cycling Development Centre.







- Each centre should have a minimum of 30 regular trainees' preferably equal number of male to female athlete ratio.
- Identification of talent pool will be done by CFI through assessment camps organized at local/district level to be called as 'Khelo India Grassroot Talent Identification'.
- Funding Model for each centre irrespective of the strength as follows:

- 9. The implementing agency for the sub-scheme shall be Cycling Federation of India and the grant shall be directly released to them by SAI for financial support as mentioned above through PFMS. CFI shall settle the amount as per the GFR norms and subsequent funding shall be provided upon submission of audited utilization certificates by CFI and acceptance by SAI.
- 10. The above proposal was placed before the PAC held on 05.03.2021 wherein it recommended the following:







- (i) The name of the Centre will be Khelo India Development Centre (KIDC) without specifying the discipline.
- (ii) Maximum non-recurring grant for a facility (Velodrome/Road/MTB) will be Rs. 05.00 Lakhs towards expenditure for creation/ up-gradation of new/ existing infrastructure, Field of Play (FOP), equipment (non-consumable), etc.
- (iii) Maximum recurring grant for a Velodrome/track facility will be Rs. 25.00 lakhs and MTB/Road facility will be Rs. 21.00 lakhs towards expenditure for Coaching & Support Staff Fee, consumables, competition/exposure, kitting and medical expense and annual maintenance with the flexibility to incur the expenditure on various heads provided there are 30 regular athletes.
- (iv) The maximum salary for the Chief Coach would be Rs.60,000/- per month OR for an Assistant Coach would be Rs. 25,000/- per month provided that an ex-champion athlete is employed in accordance with the norms of Khelo India Centre. If saving is made on Chief Coach or Assistant Coach, the grantee would have the flexibility to utilize the fund for other administrative purpose as per their requirement within the total approval of recurring grant of Rs. 25.00 lakhs and Rs. 21.00 lakhs for Velodrome and Road/MTB facilities respectively.

The approval of DPAC is sought for the following under the vertical head of Support to National/Regional/State Academies of the Khelo India Scheme:

- i) Khelo India Development Centres for approval with above-mentioned guidelines.
- ii) Adoption of 6 academies/ training centres as KIDCs with funding as recommended by PAC.







Agenda Item No. 5: Empanelment of Production Agencies with SAI

The proposal for floating of RFP for Hiring of Media Partner for Khelo India University Games was approved in the Departmental Project Approval Committee (DPAC) Meeting held on 15.12.2020. Accordingly, RFP for Production, Broadcast and Media Rights for Khelo India University Games was floated on 20.01.2021. However, no bids were received in response to the said RFP.

2. Owing to non-receipt of bids against the RFP, it is proposed that reputed Production Companies having experience in Live Production of Events may be empanelled with SAI by means of floating a Request for Empanelment (RFE) for initial period of 3 years which may be extended to another 2 years subject to satisfactory performance. W

.henever needed, such empanelment shall be used to obtain bids for Production of various events hosted by SAI/ Khelo India, including Khelo India University Games, by means of floating limited RFP. In this regard, a draft of RFE for Production Agencies has been prepared. The above proposal was placed before PAC held on 05.03.2021 wherein it was recommended to place the same before the next DPAC to meet the requirement of SAI/MYAS.

The approval of DPAC is solicited to empanel Production Agencies with SAI by means of floating RFE for Production Agencies under the vertical head of 'Annual Sports Competitions' of the Khelo India Scheme to meet the future requirement of SAI/MYAS.







Agenda Item No. 6: Financial assistance for conducting Indigenous Games in Arunachal Pradesh.

Director Sports, Arunachal Pradesh submitted a proposal regarding conduct of indigenous games at Arunachal Pradesh under Fit India by Kreeda Bharti, Arunachal Pradesh as given below:

- i. The idea is to use sports as a medium for drug abuse prevention among Young generation and children.
- ii. Kreeda Bharti will organize 3 days camp for Fitness where youth will be trained in Yoga and Martial Arts by National/State level champions and various competitions among the youth will be conducted in indigenous games. The venue will be Doimukh with participation of 400 youth.
- iii. The total expected expenditure is Rs.22,50,000/- as per the break up given below:

- iv. In view of the above, the proposal is placed for a suitable financial assistance under Khelo India vertical 'Promotion of Rural and Indigenous/Tribal Games' to Directorate of Sports, Arunachal Pradesh for conducting Indigenous Games competitions and Yoga & Martial Arts training.
- v. The proposal was placed before the PAC held on 05.03.2021 wherein it was recommended to place the same before the next DPAC with the financial requirement of Rs.15 lakhs.

The proposal for financial assistance of total expenditure of Rs.15 lakhs under the head 'Promotion of Rural and Indigenous/Tribal Games' vertical of Khelo India scheme is placed before DPAC for approval.
