### GENERAL TERMS AND CONDITIONS

1. SPORTS AUTHORITY OF INDIA, Netaji Subhas Western Centre, Sector-15, Gandhinagar, Gujarat (SAI, NSWC, Gandhinagar), invites sealed tenders from the reputed manufactures or their authorized dealers/distributors for supply of good quality **Sports Kit Items** (both general and competition/playing kit) for trainees of SAI for the year **2012-2013**, as per details given at **Annexure-I** to this tender form.
2. The word "Tenderer" as used in the Tender document shall mean the one who has signed the tender form. The tenderer may be the manufacturer/proprietor/partner or constituted attorney (in case of company) or his duly authorized representative in which case he/she shall clearly mention same while signing the tender form.

3. Partner/authorized representative or signatory/constituted attorney signing the tender document should have authority to sign the same and also submit **authorization letter** to this effect as per proforma at **Appendix-A**. The individual so authorized by proprietor/ company etc. makes the proprietor/ company etc. bound under all terms and conditions of this tender. Such authorized person shall be deemed to be authorized to bind the other person(s), on whose behalf he is signing the tender documents, for the present and future.
4. The tender document duly completed in all respects should be submitted in **3(three) separate sealed envelopes** addressed to **Director, Sports Authority of India, Netaji Subhas Western Centre, Sector-15, Gandhinagar (Gujarat)** as under:

5. **ENVELOPE- 'A'**

Shall contain crossed Demand Draft/ Pay order for Rs.50,000/- (Rupees Fifty Thousand Only) towards Earnest Money Deposit (EMD) in favour of SAI, NSWC, Gandhinagar, payable at Gandhinagar (Guj.). In case of downloading tender form, from website, a **separate** pay order/ demand draft for Rs.500/- towards cost of tender form shall also be submitted in this Envelope-"A".

6. **ENVELOPE- 'B'**

Shall contain the tender document duly filled, complete in all respects and signed by the tenderer or his authorized signatory **on each page** and a list of samples(only list, samples to be submitted separately) submitted, along with details such as name of tenderer, brand/model offered etc. (without rates) and other information as per proforma at **Annexure-II**.

Sports kit quoted should be of the best quality and only one free, non returnable sample of each item quoted be sent/submitted along with the technical bid tender.

7. **ENVELOPE- "C"**

Shall contain the Financial/Commercial Bid indicating rate for each item quoted as per proforma/format at **Annexure-III**. **Rates quoted should be inclusive of all taxes** except transportation charges. Rates quoted/offered will remain valid till the date of acceptance of the tender.

8. All the **three Envelopes** should be superscribed **“TENDER FOR SUPPLY OF SPORTS KIT 2012-13” ENVELOPE – “ \_\_\_ ” (A or B or C)**, duly sealed and submitted in one big sealed cover duly superscribed **“TENDER FOR SUPPLY OF SPORTS KIT 2012-13”**. The sealed tender envelopes should be deposited in the Tender Box provided for the purpose in the O/o SAI, NSWC, Gandhinagar, Gujarat.
9. Envelope "A" & "B" will be opened on time the and date as given in the tender document. Envelope "C" i.e. Financial/Commercial Bid of only those tenderers/bidders will be opened, whose sports kit samples are approved/selected by the designated committee/ competent authority and whose documents are found in order. Date and

Time of opening envelope "C" will be decided later and communicated to the concerned tenderers/bidders.

The Tender should be submitted by 03.30 hrs. on or before 25.01.2013 in the O/o SAI, NSWC, Gandhinagar, Gujarat which will be opened on same day at 03.30 hrs. except Envelope"C"

10. Each page of the tender should be signed by the tenderer or his duly authorized signatory indicating name and designation.
11. It must be noted that this tender is **just an enquiry** and does not amount to any commitment on the part of SAI, NSWC, Gandhinagar to order any or all products offered. The decision of SAI, NSWC, Gandhinagar, in this regard would be final and be entirely at its discretion.
12. Issue of tender documents shall not constitute that the tenderer is automatically qualified.
13. Tenderer should also submit signed **undertaking** that they have read the complete tender documents, understood it and will abide by its terms and conditions.
14. Mere acceptance of tender shall not amount to binding contract and it is only upon placement of firm purchase order that a binding contract shall come into existence.
15. Tender documents are neither transferable nor the cost of tender documents is refundable under any circumstances.
16. Those **down loading the Tender document** from our website, should pay Rs.500/- (Rupees Five Hundred Only) in the form of Demand Draft/ Pay Order in favour of SAI, NSWC, Gandhinagar towards cost of Tender Document without which their bid/offer will be summarily rejected. The Demand Drafts/ Pay Order should be enclosed in "Envelope-A".
17. **Samples** should be submitted/enclosed, discipline wise, in a non tearable bag/ envelope/cover clearly indicating the name of tenderer, number, brand/model of sports kit items on all samples as per proforma at **Annexure – II**.
18. **Warranty** period for free replacement of defective/rejected Sports Kit Items must be clearly spelt out.
19. Tender submitted without complete documents will be summarily rejected.
20. Offers sent by fax/e-mail etc will not be accepted.
21. SAI, NSWC, Gandhinagar reserves the right to reject any or all tenders at any stage/time without assigning any reason.
22. It may be noted that these are only proposed **draft terms and conditions and can be modified/ changed** or additional terms and conditions added to, at the time of finally signing the agreement.

23. In case of any difference arising in the terms and conditions of this tender document with the firm(s), the decision of SAI, NSWC, Gandhinagar will prevail.
24. Taking into account past performance of any tenderer/party, SAI, NSWC, Gandhinagar reserves the right to reject any tenderer/party.
25. Director, SAI, NSWC, Gandhinagar is the accepting authority of the tender. In the matter of award of contract or otherwise his decision will be final.
26. Even after accepting the tender, if information/facts submitted by the tenderer are found to be incorrect, misleading or false etc. SAI, NSWC, Gandhinagar reserves right to reject/disapprove any item(s) for the current/future supply or may impose penalties as deemed fit.
27. Successful tenderer is to submit an **affidavit** as at **Appendix -B**, certifying that the quality of sports kit quoted are correct and is liable to pay penalty/damages, in case of any defect. SAI, NSWC, Gandhinagar may impose penalty as deemed fit and have the right to make recovery from security deposit or bills due.
28. EMD of successful tenderer will be returned within 10 days after execution of the agreement. The successful tenderer will deposit **Security Money/deposit**, within a week, preferably in the form of **Bank Guarantee** at the rate of 10%(ten) of the total value of approved sports kit items likely to be supplied. SAI will not pay any interest for such deposit.  
  
The successful tenderer is required to make an **agreement within ten days** from the date of award of this contract for supply of sports kit items.
29. Security deposit should remain valid till a minimum period of 60 days beyond the date of completion of all the contractual obligations of the tenderer/supplier.
30. Late/Vague/Conditional/Incomplete bids, or having any cutting / overwriting or discrepancy between words and figures in any respect, will be rejected.
31. SAI, NSWC, Gandhinagar reserves right to verify **freight/transport charges** from market and in case of difference SAI rate will prevail.
32. **Rates of successful tenderers will remain valid for 24 months** from the date of execution of the contract/agreement and no increase on any account will be considered.
33. **Rates must be quoted for complete set/pair** in case of playing/competition kit, all types of shoes, track suit etc. Samples also should be submitted accordingly, i.e. set/ pair wise.
34. Tender should be submitted along with catalogue and other literature, if any, of the sports kit items(s) offered.
35. After finalization/approval, one free non returnable sample of each approved item will be retained at SAI, NSWC, Gandhinagar.
36. SAI, NSWC, Gandhinagar shall have the right to buy kit items as per samples approved or may give its own colour/pattern/design etc. if required.

37. Material indented/ordered for, shall be supplied, in full quantity within stipulated time, at the respective field units/centres/schools/camps etc. as per approved samples/specification. In case of **delayed supply or non supply/short supply/supply of poor quality** of indented items/material or any other complaints, SAI, NSWC, Gandhinagar reserves the right to reject or adjust extra liabilities from the Earnest Money/pending bills or may take any other action as deemed fit.
38. Payment shall be released by SAI against dispatch and delivery of ordered items by road/post bill/ packing list/delivery challan/ insurance etc. and after receipt of proper acknowledgement from the respective field units/ centres/ schools/ camps etc. Tenderer/supplier to forward a copy of bill along with delivery challan/packing list to SAI, NSWC, Gandhinagar, indicating supply order details, for information.
39. In case if 5% or more of any item/articles supplied by the supplier, found to be **defective in material**, size, quality, specification or any other defect etc., Director, SAI, NSWC, Gandhinagar reserves right to reject any consignment/supply, in whole or in part, without assigning any reason. In such case 10% of the total cost of the bill, in addition to refund for returned/ rejected goods will become payable to SAI.
40. In case of doubt in material supplied, expenditure incurred for getting the material tested from an accredited lab, will be borne by the tenderer or will be adjusted from his bills or any other dues.
41. SAI, NSWC, Gandhinagar reserves right to **terminate** or summarily cancel the **contract** in whole or in part, any time without assigning any reason, if the supply made is found not according to the approved sample or supply is not made within stipulated time and if SAI, NSWC, Gandhinagar feels that the supply can not be used for the event or by the group for which it was ordered.
42. The offered **Sports Kit** Items should be as per **specifications** given in **Annexure - IV**.
43. **Competition/playing kit** should confirm to the **latest specifications** prescribed by the concerned National Sports Federation for its sport for boys/girls.
44. Colour used for sports/playing kit supplied should not lose its colour, texture etc. Thread used for stitching kit should not shrink or lose its colour and should be strong enough to withstand rough use by the sportspersons.
45. **Delivery period** of the items should be within one week to four week on receipt of the supply order subject to urgency. In case of **delay in supply** of ordered items SAI reserves right to impose **penalty @ 2%** per month of the value of supply order subject to a maximum of 10% .
46. The small **SAI emblem** should be embroidered/screen printed neatly on left side at the chest level of the T-shirts and on the upper of the Track Suit and on right hand side of the Track suit lower/ pant.
47. At the top portion backside of Track suits “SAI WEST” should be screen printed in a contrast colour to be clearly visible from distance.

48. On shorts & skirts the logo of SAI be embroidered/screen printed on the front right side & “SAI WEST” on the back side of playing kit of uppers/tops.
49. The specification of SAI logos to be screen printed/ embroidered is at **Annexure-V**.
50. In the event of any dispute or differences arising between the parties with regard to terms and conditions of this tender and subsequent agreement/contract entered based on this tender and or with regard to the breach or interpretation thereof including any matter what so ever touching upon the terms and conditions of the said agreement/contract whether in course or after its termination, the parties agree to settle the same at the first instance by mutual discussion/consultation which would be conducted by the Director, SAI, NSWC, Gandhinagar.
51. In case the said mutual discussions/conciliation fail, the aggrieved party shall initiate arbitration proceeding. For resolving the differences/disputes etc. a sole arbitrator will be appointed by the Director General of SAI. Proceedings shall be conducted in accordance with the provisions of the arbitration and conciliation act 1996.
52. Venue of such arbitration proceedings shall be Gandhinagar, Gujarat or as decided by Director General, SAI and courts in Gandhinagar, Gujarat alone will have jurisdiction of all proceedings connected therewith.
53. In case of litigation, the courts at Gandhinagar only will have jurisdiction for deciding case according to law in force.
