GENERAL TERMS AND CONDITIONS

- 1. Sealed tenders are invited by Sports Authority of India from the reputed manufacturers / authorized dealers for supply of good quality sports kit (both general kit and competition kit) for Trainees of SAI for the year 2010-2011 (extendable upto 2 years) as enclosed in **Annexure I** to this tender form.
- 2. The tender shall be submitted in **three separately sealed envelops** addressed to the Director Incharge, SPORTS AUTHORITY OF INDIA, SOUTHERN REGION, MYSORE ROAD, BANGALORE- 560 056 as under:-

ENVELOPE 'A':

The demand draft/pay order of Earnest Money Deposit (EMD) for an amount of `. 50,000/- for **General Kit and Competition Kit** (Rupees Fifty thousand only) through crossed Demand Draft drawn in favor of the Director Incharge, Sports Authority of India, Bangalore payable at Bangalore will be placed in this envelope (To be submitted in Envelope – A).

ENVELOPE 'B'

This envelop shall contain the documents as mentioned in **Annexure II** of the Tender documents and a list of samples should be submitted having name of Tenderer/Brand as per proforma at **Annexure "II"** and Tender document duly singed by Tenderer or authorised signatory . (**To be submitted in Envelope – B**).

The sports kit quoted should be of the best quality and only **one free non refundable samples** be sent/submitted along with the technical bid tender document and supply shall be of the same quality submitted to and approved by the authority.

ENVELOPE 'C'

This envelope should contain the Rate's quoted for each item/brand as per Proforma at **Annexure- III (To be submitted in Envelop – C)**.

- 3. The rate/commercial/Technical offer of the firm will remain valid till the date of acceptance of tender.
- 4. The envelop containing the quotations/tenders should be sealed and be super scribed "TENDER FOR SUPPLYING SPORTS KIT" as the case may be. The sealed envelopes should be deposited in the Tender box placed in the office of Director Incharge, SAI, Southern Region, Mysore Road, Bangalore up to 2.00 noon on 2nd DEC 2010.

- 5. Envelop 'A' & 'B' submitted by the Tenderers will be opened on the same day at 3.00 p.m on 2nd DEC 2010.
- 6. **Envelop 'C' (i.e Financial Bid)** of only those tenderers will be opened, whose samples are approved/selected by the committee and all necessary documents are found enclosed. Date and time for opening of Envelop 'C' will be decided later on and communicated to those whose technical bid is accepted.
- 7. The tenderers should sign each page of the tender.
- 8. Late/Vague/conditional/incomplete/not conforming to the laid down procedure, bids in any respect will be rejected without assigning any reasons.
- 9. Offers sent by telex/fax/telegram will not be accepted .
- 10. In case of differences arising in the terms and conditions of the tender documents with the firm (s) the decision of SAI shall prevail.
- 11. After approval, one sample of each approved item will be retained free of cost at SAI, Southern Region, Bangalore.
- 12. Material indented for shall be supplied in full quantity within stipulated time to the respective field units. In case of delay in supply/non supply/shot supply/poor quality or any other complaint, SAI reserves the right to adjust extra liabilities from the Earnest money/Security Money, disapprove a brand/all brands or may take any other action as deemed fit.
- 13. SAI will have right to buy kit items as per sample approved or may give its own color.
- 14. The tender documents are neither transferable nor the cost of tender document is refundable under any circumstances.
- 15. Tenders from those tenderer who have not purchased the tender documents from SAI and not paid the cost of tender document if downloaded from website will not be considered.
- 16. The issuing of tender documents shall not constitute that the tenderers are automatically qualified.
- 17. If even after approval, information/facts submitted by a tenderer are found misleading/incorrect /false etc., SAI reserves right to disapprove an item (s) for the current/future supply or may impose penalties as it deemed fit. Non compliance of any of the terms of tender and future instructions by Incharge, SAI Southern Region will also warrant above penalties.
- 18. All clothing items must have SAI Logo screen-printed on them along with name of the south centre. The tenderer is to submit an undertaking to the

- effect that the samples submitted are as per specification at Annexure III of this tender, and any discrepancy found later on, the whole amount will be recoverable from Security Money deposited or from the bills.
- 19. Supply of General Kit and Sports playing/competition kit items may be staggered according to the orders placed from time to time during the year and place of supply.
- 20. The quantity and size of each item will be decided by the Director Incharge, SAI, Southern Region, Bangalore depending upon the No.of trainees in the scheme and Coaches in Southern Region. The rates must be quoted for complete set in case of Playing kit or Track suit etc. and accordingly the samples are to be kept like.
- 21. These are only proposed draft terms and conditions and can be modified, changed or added to at the time of finally concluding and signing the agreement.
- 22. Tenderers are required to quote for only one of its best and economical item.
- 23. All tenderers will mention technical details and specification as enclosed in appendix of **Annexure-II**
- 24. The successful tenderer will give an Affidavit certifying that the quality of goods quoted in the tender are correct and the concerned party is liable to pay damages in case of any defect. Director Incharge South Centre may impose penalty as deemed fit and will have the right to make recovery from Security or to make deduction from the bill.
- 25. The EMD of all/successful tenderer will be returned within a week after execution of the Agreement, and the successful tenderer will have to deposit the Security Money in the form of Bank Guarantee at the rate of 5% of the total value of supply order with in a week for which no interest will be paid by SAI.
- 26. In case of doubt in material the expenditure on testing of material will be born by the tenderer.
- 27. All tenderer are required to mention the name of Firm and Brand name on each sample and all the samples should be enclosed in a pollythene envelope discipline wise for display which will be displayed after opening of the technical bid.
- 28. In case of supplier exclusively supplies the sports kit items as per this tender, the authority/certificate in this regard may be enclosed with the tender.
- **29.** The detail of documents required for eligibility is given in **Annexure-II**

- 30. Tender received without the complete documents will be summarily rejected.
- 31. In case of delay in supply by the stipulated date, SAI reserves the right of imposing L.D. penalty @ 2% of the value of Supply Order subject to maximum 10% of the total cost of supply order.
- 32. The unsatisfactory performance of the agencies / firms who were on rate contract with SAI will be taken in to account while finalizing the tender.
- 33. Sales Tax/VAT and transportation charges will be paid extra and no other charges/Levi shall be paid. The tenderer should qoute the exact percentage of VAT/Sales tax that they will be charging extra for each item.
- 34. Payment will be released by SAI against dispatch of delivery of required equipment by Road/Post bill/Bill of landing, packing list, Insurance policy and certificate of origin against a value which will released after receipt and inspecting of goods supplied / acceptance.
- 35. The manufacturer/supplier should be able to give minimum guarantee of six months in case of playing kit and jersey and other items for material manufacturing defects, and undertake to replace defective products at no extra cost within a month of the defect being brought to notice of the manufacturer/ supplier.
- 36. The contract can be terminated or cancelled summarily by SAI in whole or in part any time without any notice and without assigning any reason, if the supply made by the manufacturer/supplier is not found according to the sample approved or in case supply is not received within stipulated time, and Incharge, SAI, Southern Region, Bangalore feels that it cannot be used any further for the event/camp/group for which it was requisitioned.
- 37. Director Incharge, SAI, Southern Region, Bangalore reserves the right to reject any tender in whole or in part thereof without assigning any reason. If 5% or more of any item of any one or more lots of supply, is found to be defective in material, size ,quality or any other defect of specification or manufacturing defect, then a penalty of 10% of the total prise of the lot in addition to refund for returned/rejected goods, will become payable to SAI.
- 38. Competition / Playing kit should confirm to the latest specifications prescribed by concerned Federation for its game / sport for boys & girls.
- 39. The color used for sports / competition kit supplied should not loose its colour. The stiches should be strong enough to withstand rough use by trainees. The thread used for stiching the sports / competition kit should not shrink or loose colour.

- 40. In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter what so ever touching upon the terms and conditions of the agreement/contract whether in course or on or after its termination the parties agreed to settle the same at the first instance by mutual discussions/conciliation which would be conducted by the Director Incharge, SAI, Southern Region, Bangalore.
- 41. In the event the said mutual discussions/conciliation fail, the aggrieved party shall initiate arbitration proceeding for resolution of differences/disputes etc., mentioned above by appointing a sole Arbitrator, who shall be the Director General of SAI in which event the said proceeding shall be conducted in accordance with the provisions of the arbitration and conciliation act 1996.
- 42. The venue of such arbitration proceedings shall be at Bangalore or as decided by Director General of SAI and the courts in Bangalore alone will have jurisdiction in respect of all proceedings connected there with.
- 43. Sales tax and transportation charges will be on actual basis and SAI reserve right to verify freight charges, from market and in case of difference is found SAI rate will prevail.
- 44. The successful Tenderer is required to make an agreement within one week from the date of award of this contract for supply of sports kit. The rates of successful tenderers will be valid for 24 months from the date of execution of this contract and no increase in any account will be considered.

45. **SECURITY DEPOSIT**:-

- a. Unless otherwise agreed between SAI and the contractor, the contractor shall, within 14 days of written notice of acceptance of the tender has been awarded, deposit with SAI (in cash or the equivalent in Government Securities or approved Banker's Gurantee Bond) a sum equal to 10 percent of the total value of the stores for which the tender has been accepted.
- b. Security Deposit should remain valid for a minimum period of 60 days beyond the date of completion of all the contractual obligations of the supplier.
