1. The tender shall be submitted in **four separately sealed envelope** addressed to the Principal, SPORTS AUTHORITY OF INDIA, LNCPE,P.B. NO.3 KARIAVATTOM, THIRUVANANTHAPURAM-695581 as under:-

ENVELOPE 'A' :

This envelope should contain the crossed demand draft/pay order of any nationalized scheduled Bank towards Earnest Money Deposit (EMD) for an amount of Rs. 1,00,000/-Rupees One lakh only)in favor of **The Principal, LNCPE payable at Thiruvananthapuram.** Those who downloaded the tender document, crossed demand draft/pay order of any nationalized schedules bank for a sum of Rs.1000/- to be enclosed as additional charge. Details of EMD are to be filled in Annexure-II and placed along with EMD.

The latest test Report(s) given by Government or its approved Lab. In r/o of samples (Track Suit, T-shirt, Warm Up Shoe only) submitted clearly mentioning its specifications, quality, material etc., should be submitted along with other documents mandatorily else the bid the tenderer will be rejected. ENVELOPE 'D'

This envelope should contain the financial Bid as per Proforma at **Annexure- V.** The item for which rates quoted should have the minimum technical specification detailed against each item at ANNEXURE –I of the tender document. The rate/commercial/Technical offer of the firm will remain unchanged till the date of acceptance of tender.

2. **Procedure for submission:**

Sealed envelope A, B, C & D are to be placed in a single bigger cover which should also be sealed and duly superscribed "TENDER FOR SUPPLYING SPORTS KIT ITEMS" on the top left corner of the envelop which should also have name and address of the bidder. The sealed envelope should be deposited in the Tender box placed in the office of The Principal, SAI LNCPE, KARIAVATTOM, THIRUVANANTHAPURAM up to 15:00 hrs on 18th November 2014. Those who send the tender document by post, have to ensure that the documents are reached on or before the prescribed time & date. Principal, SAI, LNCPE will not take any responsibility on delay of document under any circumstance.

- 3. **Financial Bid** of only those tenderers will be opened, who have been declared technically qualified by the committee decided by the Principal.
- 4. The tenderer should sign on each page of the tender/documents.
- 5. Late/Vague/conditional/incomplete/not confirming to the laid down procedure, bids in any respect will be rejected.
- 6. The tender documents are neither transferable nor the cost of tender document is refundable under any circumstances.
- 7. The issuing of tender documents shall not constitute that the tenderers are automatically qualified.
- 8. Even after approval, if information/facts submitted by a tenderer are found misleading/incorrect /false etc., SAI reserves the right to disapprove an item (s) for the current/future contract or may impose penalties as it deemed fit. Non compliance of any of the terms of tender and future instructions by, SAI LNCPE, Thiruvananthapuram will also warrant above penalties.
- 9. Tenderers are required to quote for only one of its best and economical items. Merely quoting the lowest rate shall not be the criteria for selection of the supplier, quality of items shall also be considered
- 10. All tenderers will mention technical details and specification of each item with supporting documents such as brochure, photo if necessary.
- 11. All tenderers are required to mention the product name and brand name on each item only in financial bid.
- 12. Bid received without Earnest Money/Sample of quoted items/conditional or in complete having cuttings or over writing is liable to be rejected.
- 13. In case of doubt in material, the expenditure on testing of material will be born by the tenderer.
- 14. The rate quoted should be inclusive of all statutory levies, taxes, packing, forwarding and for delivery at the premises of LNCPE, Kariavattom, Thiruvananthapuram, Kollam, Allappey, Thrissur, Calicut and Thalassery)
- 15. The earnest money of the unsuccessful tender(s) would be refunded through RTGS within 30 days after finalizing of tender and no interest would be paid on the amount of earnest money. The successful tenderer will have to deposit **the Security Money in the form of Bank Guarantee/Demand draft at the rate of 5% of the total value of supply** at the time of execution of contract for which no interest will be paid by SAI and same will be refunded after six months from date of supply on the satisfaction of SAI. However, in case the supplies are not found as per approved samples the security money of successful bidder will b forfeited.
- 16. The successful bidder should supply the items strictly as per the quantity, quality and the specifications mentioned in the tender and supply order.

- 17. The successful tenderes will give an Affidavit certifying that the quality of goods quoted in the tender are correct and the concerned party is liable to pay damage out of the Security in case of any defect. Principal, SAI LNCPE may impose penalty as deemed fit and will have the right to make recovery from Security or to make deduction from the bill.
- 18. Material indented should be supplied in full quantity within stipulated time. In case of delay in supply/non supply/shot supply/poor quality or any other complaint, SAI reserves the right to adjust extra liabilities from the Earnest money/Security Money, disapprove a brand/all brands or may take any other action as deemed fit.
- 19. SAI LNCPE will have the right to buy sports kit items as per sample approved or may give its own color/pattern.
- 20. All clothing items must have SAI Logo emborided/screen printed on them along with name of the centre.
- 21. The tenderer is to submit an undertaking to effect that the samples submitted are as per specification of this tender, and any discrepancy found later on, the whole amount will be recoverable from Security Money deposited.
- 22. The quantity and size of each sports kit will be decided by the Principal LNCPE on the base of the strength of trainees and coaches.
- 23. In case of delay in supply by the stipulated date, SAI reserves the right of imposing L.D. penalty @ 5% of the value of Supply Order subject to maximum 10% of the total cost of supply order.
- 24. No advance payment will be made at any cost
- 25. Payment will be released by SAI after satisfactory supply and receipt of goods in good condition supply as per supply order /approved sample . The duly filled authorization letter for release of payment thorough core banking/RTGS must be submitted along with the as per Annexure VI
- 26. The manufacturer/supplier should be able to give minimum guarantee of six months in case of all the items for material manufacturing defects, and undertake to replace defective products at no extra cost within a month of the defect being brought to notice of the manufacturer/ supplier.
- 27. The contract can be terminated or cancelled summarily by SAI LNCPE in whole or in part any time without any notice and without assigning any reason, if the supply made by the manufacturer/supplier is not found according to the sample approved or in case supply is not received within stipulated time.
- 28. The Principal, Trivandrum will have the right to forfeit the Earnest Money/Security Deposit, if the terms and conditions of the agreement are not adhered to by the supplier/breach of Contract.
- 29. Principal LNCPE reserves the right to reject any tender in whole or in part thereof without assigning any reason. If 5% or more of any item of any one or more lots of supply, is found to be defective in material, size ,quality or any other defect of specification or manufacturing

defect, then a penalty of 10% of the total price of the lot in addition to refund for returned/rejected goods, will become payable to SAI

- 30. In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter what so ever touching upon the terms and conditions of the agreement/contract whether in course or on or after its termination the parties agreed to settle the same at the first instance by mutual discussions/conciliation which would be conducted by the Principal, SAI LNCPE, Thiruvananthapuram.
- 31. In the event the said mutual discussions/conciliation fail, the aggrieved party shall initiate arbitration proceeding for resolution of differences/disputes etc., mentioned above by appointing a sole Arbitrator, by the Principal SAI LNCPE in which event the said proceeding shall be conducted in accordance with the provisions of the arbitration and conciliation act 1996.
- 32. The venue of such arbitration proceedings shall be at Thiruvananthapuram or as decided by Director General of SAI and The Judicial courts in Thiruvananthapuram alone will have jurisdiction in respect of all proceedings connected there with.
- 33. In case of differences arising in the terms and conditions of the tender documents with the firm (s) the decision of SAI shall prevail
- 34. The successful Tenderer is required to make an agreement within one week from the date of award of this contract for supply of sports kit. The rates of successful tenderers will be valid for 12 months from the date of execution of this contract.
- 35. It must be noted that this is just an enquiry and does not amount to any commitment on the part of Sports Authority of India to order any of all products offered. The decision of Sports Authority of India in this regard would be final and be entirely at its discretion.
