**ELIGIBILITY CRITERIA AND OTHER TERMS & CONDITIONS**

The Sports Authority of India(SAI) propose to set up a state-of-the-art Ayurvedic Centre to provide therapeutic and rejuvenation treatments to National Campers, Sportspersons, and guests at Jawaharlal Nehru Stadium, Indira Gandhi Sports Complex, Major Dhyan Chand National Stadium and Dr.Shyama Prasad Mukherjee Swimming Pool Complex located at New Delhi. SAI invites **Expression of Interest** from medical service providers who meet the criteria described below.

The proposed Centre seeks to provide authentic treatment for such diseases/disorders which could be treated and should become the benchmarking institution with regard to the operation of indigenous medical tourism activity.

Ayurvedic firms/hospitals/centers with a minimum of 25 years experience in the concerned field, having its presence across the country and recognized by Central/State Governments are eligible.

SAI would provide Rooms with electricity and water supply (for which the firm has to pay charge as per actual) and no license fee will be collected from the firm for the space & Room provided by SAI. Interested parties should apply with their credentials and the facilities they would provide.

The revenue from the Ayurveda and other indigenous medical packages/treatments will be shared between SAI and the selected service provider for this a transparent way of maintain the accounts will be devised. The period of contract would be initially for a period of three years, which can be extended for maximum of two years on mutual acceptance.

The selected medical service provider shall be primarily responsible for formulating various treatment packages/services in the Stadia premises with the concurrence of SAI and also for marketing of such medical services (treatment/rejuvenation therapies).

Interested parties are requested to submit their 'Expression of Interest' in the format appended herewith along with the necessary documents as listed. The EOI shall be liable for rejection in the absence of requisite supporting documents against each of the applicable requirements. The proposals would be evaluated on the basis of the eligibility criteria and interested party's experience in the relevant areas mentioned above. Evaluation of the submitted Eois falls under the sole discretion of SAI, which may choose to apply whatever conditions it deems appropriate during the evaluation. The proposals not containing Tender processing fee and EMD would be summarily rejected.
