#### TERMS & CONDITIONS FOR SUPPLY

- 01. The Tender Enquiry shall be submitted in **two separately sealed envelopes** super scribed on the top left corner of the envelopes as **"TENDER FOR SUPPLY OF SPORTS KIT"** and addressed to the **Deputy Director**, SPORTS AUTHORITY OF INDIA, Training centre, Secunderabad.
- 02. **Earnest Money amounting to Rs 10,000/-** (Rupees ten Thousand) in the form of Demand Draft issued by bank in f/o Deputy Director, Sports Authority of India, training center, Secunderabad **and the Technical Bid form** duly signed along with all relevant requisitioned documents shall be submitted in **Envelope 'A'**.
- 03. **The Financial Bid** form shall be submitted in **Envelope 'B'**.
