TENDER NOTICE

Sealed Tenders are invited from reputed manufacturers/authorized dealers for supply of SPORTS KIT to SAI STC, Dharwad Karnataka.

Tender Form with detailed information can be obtained from the o/o Sports Authority of India, STC Saptapur Road, Dharwad Karnataka - 580001 on any working day from 24/3/2015 between 10 a.m. and 1.30 p.m. on payment of cash/DD of Rs. 500/- (Rupees five hundred only) drawn in favour of SAI STC Dharwad which is nonrefundable. The tender form can also be downloaded from the website mentioned above. In case of downloading from the website the tenderer will have to remit the tender cost along with the EMD prescribed. Last date for submission of Tender will be 24/4/2015 upto 1700 hrs (5 PM).

The Centre Incharge SAI STC, Dharwad reserves the right to accept or reject any or all tenders without assigning any reasons.

TERMS AND CONDITIONS FOR SUPPLY

- 01. The tender enquiry shall be submitted in two separately sealed envelopes super scribed on the top left corner of the envelopes as "TENDER FOR SUPPLY OF SPORTS KIT" and addressed to the Centre Incharge SPORTS AUTHORITY OF INDIA TRAINING CENTER SAPTAPUR ROAD, DHARWAD KARNATAKA – 580001.
- 02. Earnest Money amounting to Rs.10,000/- (rupees ten thousand) in the form of Demand Draft issued by any national bank in favour of SAI STC DHARWAD and the Technical bid form duly signed alongwith all relevant requisitioned documents shall be submitted in Envelope 'A'.
- 03. The Financial Bid form shall be submitted in Envelope 'B'.
- 04. The supplier must submit a sample alongwith the tender document as per the TECHNICAL SPECIFICATIONS given at Annexure I.
- 05. Payment will be released after satisfactory supply and receipt of goods, supplied as per supply order. The duly filled authorization letter for release of payment through RTGS must be submitted alongwith the bid as per Annexure II.
- 06. The successful tenderer will give an Affidavit certifying that the quality of goods, rate quoted in the tender enquiry are correct and the concern party is liable to pay damage in case of any defect and that the material approved has not been supplied in the financial year to any SAI centre at a cost lower than that has been quoted in the current tender.
- 07. Both the envelopes should be clearly marked as Envelope A, B with the words "Tender for supply of Sports Kit" super scribed on the top left corner of the envelopes which should also show the name and address of the bidder.

08. Bidders are required to quote for only one of its best and economical brand.

09. The quoted sports kit should be of reputed brands.

- **10.** In case of doubt in material the expenditure on testing of material will be borne by the tenderer.
- **11.** The EMD of unsuccessful bidder will be returned within 30 days after the finalization of the tender.

- **12.** The competitive rates should be inclusive of all taxes FOR destination i.e. SAI STC Saptapur Road Dharwad, Karnataka and should be valid for a period of one year from the date of acceptance of the bid and the successful bidder has to enter into an agreement in prescribed format.
- **13.** The supplies shall be executed at the time and in the manner prescribed by the Indenting Officer. Any contravention thereof shall be deemed as a breach of contract and penalties as prescribed by the Centre Incharge SAI STC Dharwad may be imposed.
- 14. The Centre Incharge SAI STC Dharwad will have the right to reject any or all the bids without assigning any reason.
- **15.** The Centre Incharge SAI STC Dharwad has the right of awarding the work to one or different suppliers for the supply of Sports Kit.
- 16. Bids received without EMD, Samples of quoted items, conditional or incomplete, having cuttings or over writing is liable to be rejected.
- **17.** The supplies received, if not found as per the specification/samples of tendered items are liable to be rejected.
- 18. In case the bidder fails to make the supply in a given time and place, SAI shall have the right to purchase the same from the other source at the risk and cost of the supplier.
- 19. The Centre Incharge SAI STC Dharwad will be legally competent to cancel the contract of supply and also to take any other action against the supplier including imposing of any penalty on the supplier during pendency and till the final execution of the contract of the supply, and also in case the supplier is ever found to have committed any fraud against SAI STC Dharwad in supplying the material or indulge in any other malpractice thereof causing any financial losses during contract period.
- 20. The contract can be terminated or cancelled summarily by SAI in whole or in part any time without assigning any reason, if the supply made by the manufacturer/supplier is not found according to the sample approved or in case supply is not received within stipulated time.
- 21. SAI can take into account the past performance of the supplier and reserves the right to reject any tender.
- 22. The Centre Incharge SAI STC Dharwad will have the right to forfeit the EMD of the supplier, if the terms and conditions of the agreement are not adhered to by the supplier.
- 23. In case any dispute arises in regard to the tender, the decision of the Centre Incharge SAI STC Dharwad will be final and binding upon all parties.

- 24. In case of litigation, the courts at Dharwad only will have jurisdiction for deciding case according to Indian Laws in force.
- 25. The technical bid of the bidders will be opened first and the financial bid will be opened only of the bidders whose technical bill will be accepted and their samples selected by the competent authority. Financial bid will be opened on a specified date and time which will be intimated to the bidders who's technical bid is accepted.
- 26. It must be noted that this is just an enquiry and does not amount to any commitment on the part of Sports Authority of India to order any or all products offered. The decision in this regard would be final and entirely at the discretion of SAI.
- 27. These are only proposed draft terms and conditions and can be modified, changed or added to at the time of finally concluding and signing the agreement.
- 28. The tenderer should sign each page of the Tender Enquiry as a token of accepting the terms and conditions mentioned therein.
