- 01. The Tender Enquiry shall be submitted in two separate sealed envelopes super scribed on the top left corner of the envelopes as "TENDER FOR SUPPLY OF SPORTS KIT" and addressed to the, Asst. Director, SPORTS AUTHORITY OF INDIA, Training centre, Chennai.
- 02. Earnest Money amounting to Rs 10,000/- (Rupees ten Thousand) in the form of Demand Draft issued by bank in f/o, Asst. Director, Sports Authority of India training center, Chennai and the Technical Bid form duly signed along with all relevant requisitioned documents shall be submitted in Envelope 'A'.

04. Submission of Samples.- (Annexure-III)
