# TERMS AND CONDITIONS FOR SUPPLY OF FOUR TOWER AIR CONDITIONERS FOR MULTI PURPOSE HALL

- 1. Sealed Tenders are invited by Sports Authority of India from suppliers/dealers for supply and installation of four Tower Air Conditioners of reputed brand. The Tower Air Conditioners are to be installed in Multi Purpose Hall at Netaji Subhash Regional Centre, Sarojini Nagar, Kanpur Road, Lucknow (U.P.).
- 2. The word "<u>Tender for supply of Tower Air Conditioners</u>" should be super scribed on the top left corner of the envelope bearing the name & address of the tenderer. The sealed tender should accompany with the following:
  - a) Tender document completed in all respect duly signed by the tenderer, along with Earnest money amounting to Rs 11,000/- (Eleven thousand only) in the form of Demand Draft drawn in favour of Regional Director, Sports Authority of India, Netaji Subhash Regional Centre, payable at Lucknow, should be submitted in **Envelope 'A'**. In case, the amount of EMD is deposited by cheque, the tender will be rejected.
  - b) The rates quoted as per performa at **Annexure II** to be submitted in **Envelope 'B'**.
- 3. The tender shall be submitted in one envelope (containing 02 separately sealed envelopes `A&B') as above, in the office of the Director SAI Netaji Subhash Regional Centre, Sarojini Nagar, Kanpur Road, Lucknow.
- 4. If even after approval information / facts submitted by the tenderer are found misleading / incorrect etc., SAI reserves the right to reject the equipment for the current / future rate contract or may impose penalties as deemed fit. Non compliance of any of the terms & conditions of the tender will also warrant above penalties.
- 5. Rates quoted should be inclusive of taxes/vat and freight charges. F.O.R. Netaji Subhash Regional Centre, Sarojini Nagar, Kanpur Road, Lucknow.
- 6. EMD of the unsuccessful bidders will be refunded after finalization of the Tender.
- 7. Interest free performance security deposit equivalent to 10% of the total estimated value of the supply order will be deposited by the successful bidder before issue of supply order. Security Money will be refunded after expiry of warranty period.

- 8. The requirement of Air Tower Conditioners is as at **Annexure I.**
- 9. Technical specification of the Tower Air Conditioners should be as given below:-

- 10. Supply to be made & installed within 10 days from the date of Supply Order.
- 11. Subject to the provision of Force Majeure, if the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, the purchaser shall, without prejudice to other rights and remedies available to the purchaser under the contract, deduct from the contract price /security deposit, as liquidated damages, a sum equivalent to 0.5 % per week of delay or part thereof on delayed supply of goods and / or services until actual delivery or performance subject to a maximum of 10% of the contract price.
- 12. The equipment supplied if found not as per specification of tendered items, are liable to be rejected.
- 13. The Director, SAI Netaji Subhas Regional Centre, Lucknow will be legally competent to cancel the supply order and also to take any other action against the supplier including imposing of any penalty on the supplier during pendency and till the final execution of the contract of the supply, in case the supplier is ever found to have committed any fraud against SAI Netaji Subhas Regional Centre, Lucknow in supplying the material or indulge in any other malpractices thereof causing any financial losses during contract period.
- 14. In case any dispute with regard to this tender, the decision of the Director, SAI Netaji Subhas Regional Centre, Lucknow will be final and binding.
- 15. In case of litigation, the courts at Lucknow only will have jurisdiction for deciding case according to Indian law in force.
- 16. The technical bids will be opened first and the financial bid will be opened only of those bidders whose Technical bid shall be accepted by the competent authority.

- 17. It may be noted that this is just an enquiry and does not amount to any commitment on the part of Sports Authority of India to order any products offered. The decision of Sports Authority of India in this regard would be final and be entirely, at its discretion.
- 18. Director, SAI Regional Centre Lucknow reserves the <u>right to reject</u> tender without assigning any reasons. If the equipment is found to be defective in material, quality or any other defect of manufacturing defect, then the penalty of 10% of total price of the equipment will be deducted from the security deposit and in addition to, that SAI is not liable to make payment for the Tower Air Conditioners supplied.
- 19. The supplier is required to apply to the purchaser for <u>extension of delivery period</u> and obtain the same before despatch. In case the supplier despatches the Tower Air Conditioners without obtaining an extension, it would be doing so at its own risk and no claim for payment for such supply and / or any other expense related to such supply shall lie against the purchaser.
- 20. The purchaser, without prejudice to any other contractual rights and remedies available to it (the purchaser), may, by written notice of default sent to the supplier, terminate the contract in whole or in part, if the supplier fails to deliver any or all of the goods or fails to perform any other contractual obligation(s) within the time period specified in the contract, or within any extension thereof granted by the purchaser.
- 21. The warranty period of the Tower Air Conditioners should be for a minimum period of one year.
- 22. All tenderers will submit a catalogue of Tower Air Conditioners of reputed brand.
- 23. Rates should be valid for six months. No escalation in price on any account will be accepted.
- 24. The requirement of Tower Air Conditioners may be increased or decreased.
