GENERAL TERMS & CONDITIONS OF TENDER
FOR SUPPLY OF MULTI GYM EQUIPMENTS FOR STC TRAINEES

1. Earnest money amounting **Rs.10,000/-** in the form of Demand Draft from any Nationalized Bank in favor of In-charge, SAI Training Centre, Dharamshala payable at Dharamshala. Tender Document duly signed along with relevant/requisitioned documents shall be submitted (Technical Bid in Envelope 'A') & (Earnest Money in Envelope-'B') respectively. However, the said deposited amount on account of Earnest Money will not carry any interest.
2. The Financial bid should be submitted in Envelope 'C'.
3. Samples along with specification and relevant details should be ready for display at Dealer/Manufacturer's shop/factory. Material Selection committee would inspect the sample at premises/factory of the Firm/dealer at any time.
4. Samples shall have to be displayed by Concerned Agency on requirement and on the day and time decided by this Office.
5. All the bids should be submitted in a large envelope should be super scribed with words "Tender for supply of Sports Equipment/Goods" on the top of the left corner of the envelope which should also show the name and address of the bidder.
6. Bidders are required to quote for only one of its best and one economical brand of each item.
7. The quantity of each item will be decided by the In-charge, SAI Training Centre, Dharamshala.
8. In case of doubt in material the expenditure on testing of material will be borne by the tenderers.
9. Successful bidder shall execute an agreement for the due performance of this contract on non-judicial stamp paper worth Rs.50/- within 10 days of the receipt of the supply order.
10. Successful bidder shall have to deposit an interest free security money @ 5% of the estimated value within 10 days of the receipt of the supply order which will be refunded on the expiry of the contract.
11. EMD to the unsuccessful bidder will be refunded after finalization of the contract and of successful bidder on execution of agreement and deposit of security money.
12. Competitive rates should be inclusive of all taxes and F.O.R quoted in Tender should be valid up to 31st March, 2016 from the date of acceptance of bid. As per requirement, the goods may be procured in piecemeal manner up to 31st March, 2016.
13. Items quoted by the firms should be strictly as per standard specifications.

14. The supplies shall be executed at the time and in the manner prescribed by the Indenting Officer. Any contravention thereof shall be deemed as a breach of contract and penalties as prescribed by the In-charge, SAI Training Centre, Dharamshala may be imposed.
15. The In-charge, SAI Training Centre, Dharamshala will have the right to reject any or all the bids without assigning any reason.
16. Bids received without Earnest money, Samples of quoted items, conditional or incomplete having cuttings or overwriting are liable to be rejected.
17. The supplies received, if not found as per specification of tendered items, are liable to be rejected.
18. In case the bidder fails in making the supply in a given time and place this Office shall have the right to purchase the same from the other source at the risk and cost of the approved supplier.
19. In-charge, SAI Training Centre, Dharamshala will be legally competent to cancel the contract of supply and also to take any other action against the supplier including imposing of any penalty on the supplier during pendency and till the final execution of the contract of the supply, in case the supplier is ever found to have committed any fraud against SAI Training Centre, Dharamshala or any Office of the SAI, in supplying the material or indulge in any other malpractice's thereof causing any financial losses during contract period.
20. The contract can be terminated or cancelled summarily by SAI in whole or in part at any time without assigning any reason, if the supply made by the manufacturer/supplier is not found according to the sample approved or in case supply is not received within stipulated time.
21. In-charge, SAI Training Centre, Dharamshala have the right of awarding the work to one supplier or different suppliers for the supply of sports goods.
22. The SAI taking into account past performance of the party concerned reserves the right to reject any tender.
23. All the Bid documents, supporting papers etc. submitted by Firm/Bidders should be duly signed, quoting name & address of Firm along with seal /stamp of Firm.
24. Tenderer must be having annual turnover of Rs.15.00 lakhs (per annum) during the last 3 preceding years, as per the Trading and Profit & Loss Account and preferably having minimum three years experience in supplying of sports goods to Government Departments or Public Sector Undertakings.
25. In-charge, SAI Training Centre, Dharamshala will have the right to forfeit the earnest money, if the terms & conditions of the agreement are not adhered to by the supplier and done a breach of contract.

26. In case any dispute arises in regard to the tender, the decision of the In-charge, SAI Training Centre, Dharamshala will be final and binding.
27. In case of litigation, the courts at Dharamshala only will have jurisdiction for deciding case according to Indian laws in force.
28. The technical bid of the bidders will be opened first, thereafter samples will be evaluated. The financial bid will be opened only of the bidders whose Technical bid is accepted & whose samples are selected by the competent authority.
29. It must be noted that this is just an enquiry and does not amount to any commitment on the part of Sports Authority of India to order any or all products offered. The decision of Sports Authority of India in this regard would be final and be entirely, at its discretion.
30. These are only proposed draft terms and conditions and can be modified, changed or added to at the time of finally concluding and signing the agreement.

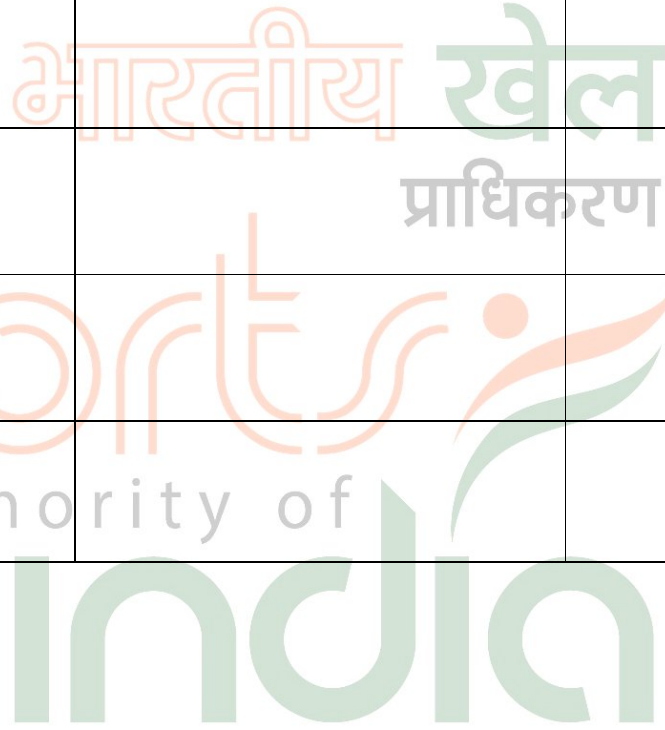
