- 1.2 The bidders are required to accept all terms & conditions mentioned in the Tender Document. SAI reserves the right to reject any or all offers without assigning any reason thereof.
- 1.3 It is the responsibility of the bidders to read all terms & conditions of the tender document before filling the tender. Incomplete tender documents or bids are liable to be rejected.

- 1.5 SAI also reserves the right not to accept the lowest bid.

4. SCOPE OF WORKS

- 4.2 SAI requires monitoring of incoming and out-going movements of staff, outsiders and suppliers of goods, equipment and safety and monitoring of guards at SAI Training Centre Bolpur which cannot be carried out except the specialized experience.
- 4.3 To operate existing **Generator** & the **Fire Extinguisher set** SAI Training Centre Bolpur only on emergency/ urgent demand/ timings.

5.TERMS AND CONDITION

- 5.1 The bids must be accompanied with a Bank Draft/ Pay Order issued by any Nationalized / Scheduled bank for Rs. 25,000/- (Rupees Twenty five thousand only) in favour of Sports Authority Of India, SAG Centre, Bolpur.
