The Bidder must be a reputed Manufacturer or Authorized reseller/Agents/Dealers of the original Equipment Manufacturer with prior experiences of having supplied Para sports Equipment.

> Modes of Submission

All interested bidders shall pay a minimum of 5% of the tender amount as EMD and Processing fee and submit their TENDER responses through Sealed Tender only. The minimum EMD amount should not be less than Rs 2,40,000/-

Companies shallsubmit the bids only through the sealed tender system before the scheduled date and time for bid submission. Submitted after the due date and time will not be considered and Paralympic Committee of India will not be liable or responsible for any delays.

6.2 Language of Bids

The Bids prepared by the Bidder and all correspondence and documents relating to the bids exchanged by the Bidder and Paralympic Committee of India, shall be written in English language.

6.3 Bid Prices

a) The Bidders submitting the bid for Indigenous Equipment/ Goods or already imported Equipment/ Goods should quoted in Indian Rupees. In case of the imported equipment, the applicable customs duty(if any) GST, C&F charges, Local Transportation and other miscellaneous charges etc be also quoted specially for ascertaining the landed cost of the goods.

- b) If the C&F price quoted by the Bidder is in US dollars/ Euros/ Great Britain Pounds, the quoted price will be converted to Indian Rupees for the purpose of equitable comparison and evaluation. For this purpose the Authority will consider the exchange rates of the Reserve Bank of India published in Reserve Bank of India Website, as on the date of Bid opening.
- **c)** Prices quoted in the Bid must be firm and final and shall not be subject to any upward modifications, on any account whatsoever.
- **d)** The contract shall be, inclusive of all duties and taxes. The Bidders shall quote their bids for entire scope of work without any additions, alterations and conditions. The contract price quoted by the Bidders should include all costs associated with the supply, including any out of pocket/ mobilization expenses, packing/unpacking charges, freight, loading/unloading charges, transit insurance, duties, taxes, charges, levies, cess, GST, etc.

6.4 Bidder Qualification

The "Bidder" as used in the documents shall mean the one who has signed the Form. The Bidder may be either the Principal Officer or his duly Authorized Representative, in either cases he/ she shall submit a certificate of authority. All certificates and documents (including any clarifications sought and any subsequent correspondences) received hereby, shall, as far as possible, be furnished and signed by the representative and the principal.

It is further clarified that the individual signing the documents in connection with the bid must certify whether he/she signs as the Constituted attorney of the firm or a company.

6.5 Bid Security (Earnest Money Deposit)

The Bid shall contain a minimum EMD amount of **Rs.2,40,000.00(Indian Rupees Three lakhs only)** and shall be paid through Demand Draft in the favour of Paralympic Committee of India.

Demand Draft should be submitted along with the Sealed Tender.

The bidder shall be disqualified in the Evaluation process if the prescribed EMD is not submitted along with the bid. The EMD (bid security) of the unsuccessful Bidder/s will be discharged / refunded after 45 days. No interest will be payable by Paralympic Committee of India for the amount of the Bid Security.

6.6 Rejection of Bid:

Any effort by a Bidder to influence the Paralympic Committee of India in its decisions on bid evaluation, bid comparison or contract award may result in rejection of the Bidder's bid and forfeiture of the EMD.

6.6.1 Rejection Criteria

Besides other conditions and terms highlighted in the document, bids may be rejected under following circumstances:

7 Selection of the successful Bidder:

a) Once the financial quotations of all bills are evaluated, the bidder quoting the least amount will be ranked as L1.

In case the withdrawal or backing out by the L1 bidder, a chance to L2/L3 bidders can be considered provide the match the L1 price although all other technical and commercial terms of L1 bidder.

- b) The bidder ranked L1 shall be declared as the successful Bidder.
- c) The successful Bidder would be notified in Writing by the Authority by issuing the Letter of Award (LOA) in favor of the Bidder, following which a contract Agreement shall be executed between the Authority and Successful Bidder.
- d) Any costs incurred to this assignment, from the time of receiving of LOA till the signing of the contract shall be borne by the Bidder and no additional costs shall be paid by the authority.

8 Warranty:

a) All the equipment supplied by the selected agency shall be guaranteed for satisfactory performance for a period of 5 months from the date of delivery. If any of the items are found defective due to design, materials or workmanship or from any act or omission of the supplier, during these 5 months, the selected agencies shall

promptly replace or rectify the defective items within a reasonable time free of cost, at the destination of delivery

b) If the supplier, having been notified of the defected, fails to rectify/ replace the defect(s) in reasonable timeframe, the Authority may provide to take such remedial action(s) as deemed fit by the Authority, at risk and expense of the Selected Bidder and without prejudice to other contractual rights and remedies, which the Authority may have against the supplier.

8.1Packing of Equipment:

The Equipment should be provided with suitable strong and durable packing to withstand all sorts of transit hazards, rough handling during transit and strong, till it reach the final designed delivery site.

8.2 User Manual and Support Services:

Supplier shall provide all necessary services and or support to assemble and install the equipment for its proper use at no charge to the Authority. Supplier shall also, provide the necessary user manuals and guide books along with the equipment and if so requested by the Authority will also provide one time demonstration of the usage of the equipment to ensure proper function of the equipment. Any fittings or accessories which are ancillary for the proper use of the equipment shall be provided by the supplier without extra charge and equipment must be complete in all details.

9 Arbitration:

The parties shall seek to resolve, in good faith, any dispute, controversy claim or breach arising out of transactions in relation to this Agreement, by Alternative Dispute Resolution.

The seat of arbitration shall be Delhi, India and language will be English.

9.1 Jurisdiction:

Any matter related to this sealed Tender shall be subjected to the Jurisdiction of the Courts at Delhi, India and will be governed by the Laws of India.

9.2Applicable Law:

The contract shall be governed by and interpreted in accordance with the laws of India.
