- 1. The SAI NERC Imphal has issued these Bidding Documents for purchase of Furniture items as per technical specification mentioned.
- 2. Before formulating the Bid and submitting the same to the SAI NERC Imphal, the Bidder should read and examine all the terms, conditions, instructions etc. contained in the Bidding Documents. Failure to provide and / or comply with the required information, instructions etc. incorporated in these Bidding Documents may result in rejection of its Bid.
- 3. The Bid submitted by the Bidder and all subsequent correspondence and documents relating to the Bid exchanged between the Bidder and SAI NERC Imphal, shall be written in the English language.
- 4. It is the responsibility of Bidder to go through the Bidding Document to ensure furnishing of all required documents.
- 5. The authorized signatory of the Bidder must sign the Bid duly stamped at appropriate places and initial all the remaining pages of the Bid.

- 8. Payments Shall be made through through PFM System. Bidders are required to fill and attach the PFMS Mandate Form along with their offers.
- 9. The price of the goods should be inclusive GST and transportation charges etc.


