Instructions to Bidders and Terms & conditions

- 1) Tender document can be had from SAI Training Centre, Indoor Stadium Complex, Rajaji Cross Road, Calicut – 673 004, between 10 am and 4 pm on all working days or can be downloaded from the Web www.lncpe.gov.in, www.sportsauthorityofindia.nic.in
- 2) Cost of Tender form for each items viz., (1) Grocery, (2) Non-Veg., & Egg, (3) Fish and (4) Fruits & Vegetables will be Rs.200/-and DD drawn in favour of the Centre In-charge, SAI Training Centre, Calicut, to be attached with the tender form in case the tender form is downloaded. Separate Tender forms should be submitted for each item.
- 3) Date for submission of bids will commence from 25/10/2017 and close at 1.00 pm on 08/11/2017. Tenders will be opened at 3.00pm on 08/11/2017.
- 4) The sealed envelope, containing the separate sealed envelope “A” of “**Technical Bid**” and envelope “B” of “**Financial Bid**”, should be super scribed as ‘**Tender for the Supply of _____**’ (the particular item/s i.e., Dry Rations or Non-Veg. & Egg or Fish or Fruits & Vegetables or all).
- 5) The Tender form “**Technical Bid**” should be attached with an EMD amount for each item i.e., (1) Grocery –Rs.10,000/-, (2) Non-Veg. & Egg – Rs.5,000/-, (3) Fish – Rs.2,500/- and (4) Fruits & Vegetables – Rs.5,000/- on DD drawn in favour of the Centre In-charge, SAI Training Centre, Calicut and payable at Calicut. The tender without EMD will not be entertained.
- 6) The rate should be valid for a period of 1 year. The period of supply will be one year from the date of agreement executed to this effect, which can be extended on mutual agreement.
- 7) The successful bidder should enter into an agreement with the Centre In-charge, SAI, Training Centre, Calicut in Rs.200/- stamp paper in the prescribed format of this institution for items viz., (1) Grocery, (2) Non-Veg., & Egg, (3) Fish and (4) Fruits & Vegetables.
- 8) No advance payment will be made. The payment will be made only through NEFT to the Bank account of the successful bidder at the end of each month after satisfactory supply of the items for the particular month, which the bidder has to submit the bank detail (Cancelled Cheque / copy of the Bank Pass book).
- 9) The successful Bidder will have to execute supply strictly according to the Terms and Conditions agreed up on. Any contravention thereof shall be deemed as a breach of Contract and penalties as prescribed in the agreement will be imposed. Materials indented for shall be brought to the Mess Stores at the cost of the supplier.
- 10) The bidder should have at least 2 years minimum experience in the field of supply of food materials to any reputed organizations.
- 11) Rates as Tendered will be inclusive of all Taxes and delivery charges and no extra claim on this account will be entertained.
- 12) All the items supplied should be fresh and on time as per indented and supply should be made in the presence of the authorized officer. Any of the items supplied found to be inferior in quality, the same will summarily be rejected and good quality items should be supplied by the bidder within the stipulated time.
- 13) Short weight shall be treated as non-supply of the item concerned and remaining quantity should be supplied within the stipulated time. If the supplier fails to supply the items on time

the required items will be purchased from the market and the loss if any will be recovered from the supplier. In case of non-satisfactory supply the agreement will be terminated with due notice.

- 14) In case of requirement of any related item which is not mentioned in the Tender form, the Bidder will be liable to supply such item as per the indent at a prevailing/reasonable market rate.
- 15) Bills for the supply for a month in duplicate may be submitted on or before the last day of the month.
- 16) The performance security deposit amount (1) Grocery – Rs.30,000/-, (2) Non-Veg. & Egg – Rs.12,000/-, (3) Fish – Rs.10,000/- and (4) Fruits & Vegetables – Rs.12,000/- should be made in the form of Demand Draft drawn in favour of ‘The Centre In-charge, SAI Training Centre, Calicut’ within 3 days of the award of the contract.
- 17) No conditional tender will be accepted.
- 18) In case of any dispute arise in the matter the decision of the Centre In-charge/Court of law within Calicut jurisdiction will be final and binding.
- 19) The Centre In-charge reserve the right to accept or reject any quotation in full or in part without assigning any reasons thereof.
- 20) A copy of TAN/PAN card and Copy of Income Tax return for the last two years should be attached with the Technical Bid.
