01. The Tender Enquiry shall be submitted in **two separate sealed envelopes** super scribed on the top left corner of the envelopes as **"TENDER FOR SUPPLY OF VEGITABLES AND FRUITS"** and addressed to the, **Deputy Director**, **SPORTS**

AUTHORITY OF INDIA, Training centre, gachibowli stadium, hockey complex, Hyderabad 500 032

- 02. Earnest Money amounting to Rs 6,000/- (Rupees S i x Thousand only) in the form of Demand Draft issued by bank in f/o, Deputy Director, Sports Authority of India training center, Gachibowli stadium, Hockey complex, Hyderabad. and the Technical Bid form duly signed along with all relevant requisitioned documents shall be submitted in Envelope ,A".
- 03. **The Financial Bid** form shall be submitted in **Envelope "B'**.
- 04.
