Sports Authority of India, Sports Training Centre, Dharamshala invites sealed bids for 'Disposal of Unserviceable(condemned/obsolete) Sports Equipments and Other Misc. items' from Scrap Dealer (s)/Dismantler(s)/Recycler(s). Bidders have to deposit the Earnest Money Deposit (EMD) of Rs. 2,000/- (Rupees Two Thousand Only) in the form of Demand Draft/Banker's Cheque in favour of 'In-charge SAI Training Centre' payable at Dharamshala. The Tender Document having detailed instructions and terms & conditions can be downloaded from the website www.sportsauthorityofindia.nic.in. There is no tender fee nor any fee required to be paid at the time of submission of bids. The last date of receipt of completely filled-up bid document By Hand in the office of the undersigned is 29.03.2017 up to 1500 hours. The Bids will be opened on 30.03.2017 at 1100 hours in the presence of the bidder who wish to remain present. No tender by Fax/E-mail will be entertained. Conditional tender shall be summarily rejected. Incharge, STC Dharamshala reserves the right to accept or reject any or all bids without assigning any reason. Further, Addendum/Corrigendum, if any shall be uploaded onto the official website of SAI.

TERMS AND CONDITIONS OF THE TENDER

DISPOSAL OF UNSERVICABLE (CONDEMNED) SPORTS EQUIPMENTS AND MISC. ITEMS

1. Earnest Money Deposit

- i. The Earnest Money Deposit (EMD) Rs.2,000/- (Rupees Two Thousand only) should be accompanied with the bid(Financial/Price Bid- Annexure-II) in the form of Demand Draft/Banker Cheque drawn in favour of 'In-charge SAI Training Centre' payable at Dharamshala Bid received without EMD or EMD for fewer amounts will be summarily rejected. The submission of EMD is compulsory for all the bidders and no exemption will be granted for submission of EMD in any case.
- ii. EMD will be forfeited if the bidders withdraw after submission of the bids or opening of the bids.
- iii. EMD will be returned to the unsuccessful bidders three days after bid opening.
- iv. EMD will be adjusted for the purpose of final payment by the successful bidder.

2. Payment of entire bid amount

The successful bidder will have to pay the entire bid amount in the form of demand draft drawn in favour of '**In-charge SAI Training Centre**, **Dharamshala'** before taking away the items which should be not less than 3 days of the bidding.

3. Mode of Submission of bid and last date for submission

Financial/Price Bid as per prescribed format **(Annexure-II)** along with **Demand Draft of EMD** in a sealed envelope should be addressed to the **Centre In-charge, STC, Dharamshala**, and must reach on or before **29.03.2017 by 1500 hrs**. Bidders may be hand delivered at the afore mentioned address. Bids received after the closing date and time prescribed shall **NOT** be accepted under any circumstances.

4. Rejection of incomplete and conditional bids

The incomplete and conditional bids will be rejected.

5. No withdrawal after submission of bids

No bidders will be allowed to withdraw after submission of bids/opening of the bids, otherwise the EMD submitted by the firm would be forfeited.

6. Non transferability

This bid is non transferable.

7. Bidding for the entire range of items meant for disposal

The bidders have to bid for entire lot. Bidding for select items will not be entertained.

8. Removal of the goods at the bidders cost.

The successful bidder has to take away the items at their own cost within 3 days after making complete payment of the items. Prescribed security procedure has to be followed for taking away the items from the STC Dharamshala premises. In case, the successful bidder deposits the full amount within 3(three) days but fails to lift the articles, the department shall not take responsibility for safe custody of the articles. On the other hand ground rent @1% of the total amount of the bid value shall be charged for each day of default up to maximum 10 days. In case, the successful bidder is unable to take delivery of the items even after penalty of 10 days, EMD submitted by them will be forfeited and the bidder will be blacklisted.

9. As is where is basis condition.

Items will be disposed of on "As is where is basis".

10. Inspection of the items.

11. General

- i. All the labour charges towards loading, uploading and transportation charges, etc. shall be borne by the successful bidders. No claims and complaint what so ever, would be entertained on account of lifting and transportation.
- ii. The undersigned reserves the right to accept or reject any bid without assigning or communicating any reason thereof.
- iii. If any bidder finds any irregularity or omission or is in doubt he should at once intimate the Centre Incharge, STC Dharamshala in writing and obtain clarification in writing 7 days prior to submission of the bidder. Verbal clarification given by any of the staff shall not be binding on the STC Dharamshala.
- iv. The legal address with mobile no. of the bidder shall be furnished in the tender paper for correspondence.
