The period of the contract may further be extended after successfully completion of one year provided the requirement of the SAI for manpower persists at that time or may be curtailed/discontinue before one year owing to deficiency in service or substandard quality of manpower deployed by the selected Service Provider or because of changes in the SAI requirements. The SAI, however, reserves right to terminate this initial contract at any time after giving a 30 days notice to the selected Service Provider without assigning any reason what so ever.

- 1. The consolidated amount of DC Rates payable at Rohtak, Govt. of Haryana shall be inclusive of all statutory / taxation liabilities in force at the time of entering into the contract and as per the minimum wages as fixed from time to time.
- 2. The selection criteria shall be the Rate of service charges to be quoted by the Bidders for providing the manpower vary as per requirement from time to time.
- 3. The payment shall be made on conclusion of the Calendar month only on the basis of no. of working days for which duty has been performed by each manpower.
- 4. Firms shall be paid DC Rates payable at Rohtak, Govt. of Haryana plus Service Charges as quoted by them in Col. No. 3 & 4 above.
- 5. No other amount of any kind shall be paid in addition.

TERMS AND CONDITIONS

General:

- The contract shall commence from the date of award of letter and shall be continued till
 one year from the date of award of contract, unless it is curtailed or discontinue by the
 Chief Operating Officer, SAI NBA Rohtak owing to deficiency of service, sub-standard
 quality of manpower deployed, breach of contract etc or change in requirements of the SAI
 NBA Rohtak.
 - 2. The contract for providing the aforesaid manpower is likely to commence from the date of award of letter and would continue till one year from the date of award of contract. The period of the contract may further be extended after successfully completion of one year provided the requirement of the SAI for manpower persists at that time or may be curtailed/discontinue before one year owing to deficiency in service or substandard quality of manpower deployed by the selected Service Provider or because of changes in the SAI requirements. The SAI, however, reserves right to terminate this initial contract at any time after giving a 30 days notice to the selected Service Provider without assigning any reason what so ever.
- 3. The contract shall automatically expire after completion of one (01) year\ unless extended further by mutual consent of contracting agency and the SAI NBA Rohtak.
- 4. The contract may be extended, on the same terms and conditions or with some additions/ deletions/ modifications, for a further specific period mutually agreed upon by the successful service provider Agency and SAI NBA Rohtak.
- 5. The contracting Service provider shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this contract to any other agency without the prior written consent of the SAI.
- 6. The SAI NBA Rohtak, at present, has requirement of as referred to S.No.5 of Tender Document/Bid; 01-Jr. Accountant, 01-Data Entry Operators, 06- Multi task Force, 01 Male Warden, 01 Female Warden and 01 Masseur, 01- DEO below graduate) on urgent basis. The requirement of manpower of SAI NBA, Rohtak may further increase or decrease marginally, during the period of initial contract also, and the Tenderer would have to provide additional manpower service on need basis, if required on the same terms and conditions from time to time.
- 7. The Service Provider will be bound by the details furnished by it to the SAI NBA Rohtak while submitting the Tender or at subsequent stage. In case, any of such details/ documents furnished are found to be false at any stage, it would be deemed to be a breach of terms of contract making the tender liable for legal action besides termination of contract.
- 8. The Chief Operating Officer, Sports Authority of India, NBA Rohtak reserves right to terminate the Contract during any time after giving a 30 days' Notice to the Contracting Agency.
- **9.** The persons/staff/employee deployed shall be required to report at duty point for works at 09.30 AM to In-charge of respective Section/Division at SAI NBA, Rohtak and would leave at 6 PM. In case, the person deployed is absent on a particular day or comes late/leaves early on three (03) occasions, proportionate deduction for one day salary will be made.
- 10. The Service Provider Agency shall nominate a Coordinator/Supervisor who would be responsible for immediate interaction with the SAI NBA Rohtak so that optimal services of the persons deployed by the Manpower Provider Agency could be availed without any disruption.

11. The entire financial liability in respect of manpower services deployed in the SAI NBA Rohtak shall be that of the Manpower Service Provider Agency and the SAI NBA Rohtak will in no way be liable for any financial liability.

- 12. For all intents and purposes, the Manpower Service Provider shall be the 'Employer' within the meaning of different Labour Legislations in respect of manpower so employed and deployed in SAI NBA, Rohtak. The persons deployed by the Manpower Service Provider in SAI NBA Rohtak shall not have any claims whatsoever like; Employer and Employee relationship against Sports Authority of India, NBA Rohtak.
- 13. The Manpower Service Provider Agency shall be solely responsible for the redressed of grievances/ resolution of disputes relating to persons deployed. The SAI NBA Rohtak shall, in no way, be responsible for settlement of such issues whatsoever.
- 14. The SAI NBA Rohtak shall not be responsible for any financial loss or any injury to any person deployed by service provider in the course of their performing the functions/duties, or for payment towards any compensation/treatments etc.
- 15. The persons deployed by the Manpower Service Provider shall not claim, nor shall be entitled to pay, perks and other facilities admissible to regular/confirmed/temporary employees of the SAI NBA Rohtak during the contract period or after expiry of the contract.
- 16. In case of termination of this contract on its expiry or otherwise, the persons deployed by the Manpower Service Provider shall not be entitled to and will have no claim for any absorption in the regular/ otherwise capacity in the SAI NBA Rohtak.
- 17. The persons so engaged on contract through the Manpower Service Provider Agency will have no right what so ever to have temp/regular employment in SAI NBA Rohtak.

LEGAL:

- **18.**The personnel during course of their work shall be privy to certain qualified documents and information which they are not supposed to divulge to third parties. In view of this, they shall be required to take oath of confidentiality and breach of this condition shall make the Manpower Service Provider as well as the person concerned liable for penal action under IPC, Cr. P.C. or any other relevant provision besides, action for breach of contract.
- 19. The Manpower Service Provider Agency shall comply with all the Labour Laws in vogue including; The Payment of Wages Act 1936, the Contract Labour (R&A) Act-1970, The Child Labour (R&A) Act-1986, ESI Act-1948, the Equal Remuneration Act-1976, the EPF & Misc. Provisions Act-1952. The Manpower Service Provider Agency is bound to comply with all other applicable statutory provisions even if it is not indicated herein expressly.
- 20. The Manpower Service Provider Agency will be responsible for compliance of all statutory provisions relating to Wages, Provident Fund & Employees State Insurance etc. in respect of the persons deployed by it in the SAI NBA Rohtak. The SAI NBA Rohtak shall have no liability in this regard.
- 21. The Manpower Service Provider Agency shall also be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to SAI NBA Rohtak to the concerned Tax Collection Authorities from time to time as per extant Rules and Regulations in the matter.
- 22. The Tax Deduction at Source (T.D.S) shall be done as per the provisions of Income Tax

- Act/Rules, as amended from time to time and a Certificate to this effect shall be provided to the Manpower Service Provider Agency by the SAI NBA Rohtak.
- **23**. The service provider shall maintain all the Statutory Registers under the Law. The Manpower Service Provider Agency shall produce the same, on demand, to the concerned authority of the SAI NBA Rohtak or any other authority under Law.
- 24 In case, Manpower Service Provider Agency fails to comply with any Statutory/Taxation liability under appropriate law, and as a result thereof the SAI NBA Rohtak is put to any loss/obligation, monitory or otherwise, the Sports Authority Ministry will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the Manpower Service Provider Agency, to the extent of the loss or obligation in monetary terms.

FINANCIAL:

- **25.**The Technical Bid should be accompanied with an EMD, refundable without interest, of Rs,50,000/- in the form of DD/Pay Order drawn in favour of Chief Operating Officer, SAI NBA Rohtak **failing which the Tender shall be rejected out rightly.**
- 26. The Earnest Money Deposit in respect of the agencies which do not qualify the Technical Bid (First Stage)/Financial Bid (Second competitive stage) shall be returned to them without any interest within 30 days. However, E.M.D. in respect of successful Tenderer shall be adjusted towards the Performance Security Deposit. Further, if the Manpower Service Provider Agency fails to deploy the required manpower against the initial requirement within 15-20 days from the date of placing the orders, the Performance Security shall stand forfeited without giving any further notice.
 - **27.** The Successful Tenderer will have to deposit a Performance Security amount of **Rs. 1 Lakh** in the form of Bank Guarantee/ Demand Draft from any Nationalized Bank drawn in favour of Chief Operating Officer, SAI NBA Rohtak covering the period of contract. In case, the contract is further extended beyond the initial period, the Bank Guarantee will have to be accordingly renewed by the successful tender.
- **28.** In case of breach of any terms and conditions the Performance Security Deposit of the Manpower Service Provider Agency will be liable to be forfeited by the SAI NBA Rohtak besides annulment of the Contract.
- 29. The Manpower Service Provider Agency shall raise the bill, in duplicate, along with attendance sheet (duly verified by Chief operating Officer, Sports Authority of India NBA Rohtak in respect of the persons deployed and submit the same to Chief Operating Officer, SAI NBA Rohtak in the First week of the succeeding Month. As far as possible the payment will be released by the Second week of the succeeding Month.
- **30.** The claims in bills regarding Employees State Insurance, Provident Fund, and Service Tax etc. should be necessarily accompanied with documentary proof pertaining to the concerned bill of each month. A requisite portion of the bill/whole of the bill amount shall be held up till such proof is furnished, at the discretion of the SAI.
- **31.** If there is any delay by the Manpower Service Provider Agency, in releasing/payment of monthly salary to the engaged/deployed persons on contract basis in SAI NBA Rohtak, beyond 7th of each month, the Manpower Service Provider Agency shall liable to pay penalty @ Rs.500/per day, which shall be deducted from the monthly bills of the Manpower Service Provider Agency in the following month.
- **32.** If there is any delay by the Manpower Service Provider Agency, in providing a suitable substitute for the absentee for a period beyond three (03) working days, the Agency shall be

- liable to pay penalty at the rate of Rs.1000/- per day for each absentee, which shall be deducted from the monthly bills of the firm in following month.
- **33.** The Director General, Sports Authority of India reserves the right to withdraw/relax any of the terms and condition mentioned above so as to overcome the problem encountered at a later stage.
 - **34.** If the parties fail to resolve their dispute or difference by mutual consultation within twenty-one days of its occurrence, then either the Manpower Service Provider Agency or the SAI may give notice to the other party of its intention to commence arbitration, in the manner hereinafter provided and the arbitration procedure will be as per the Arbitration & Conciliation Act, 1996 Govt. of India.
 - **35.** The dispute or difference arises between the Manpower Service Provider Agency and SAI relating to any matter arising out of or connected with the Contract, shall be referred to the Sole Arbitrator to be appointed by the Director General, Sport Authority of India. The award of the arbitrator will be final and binding on the parties to contract.
