Sealed and competitive tenders in two bid system (Technical & Financial) are invited from reputed dealers having annual turnover of 1 Crore and above for the purchase of ROWING BOATS for Paddling Pool for the use of Sports Authority of India. The tenders super scribed as "Purchase of Trainer Type Centre Part Rowing Boats (Coxless Four) for Paddling Pool – SAI Water Sports Centre Alappuzha" on the top of envelop and addressed to the Centre In-Charge, Water Sports Centre, Alappuzha PIN – 688 006 should reach in the office before 13.00 hrs on 18 Apr 2016. The tenders will be opened on 18 Apr 2016 at 14.00 hrs, in the presence of the competitors or their authorized representatives. The financial bid will be opened only if Technical bid is satisfactory and the specification of quoted item is as per the notification. (The details of items required and specification attached).

- 1. Last Date of Receipt of sealed tender at SAI Water Sports Centre Alappuzha is before 13.00 hrs on 18 Apr 2016.
- 2. Date & Time of opening of tech-bid in SAI Water Sports Centre Alappuzha: 14.00hrs on 18 Apr 2016.
- 3. Earnest Money Deposit Amount : Rs 10,000/-.
- 4. Cost of Tender Document: Rs 500/- (Rupees Five Hundred only)
- 5. Sealed tenders should be dropped in the Tender Box in the office of Centre In- Charge SAI Water Sports Centre, Punnamada, Alappuzha.
- 6. Date & Time of opening of bid at SAI Alappuzha is 14.00 hrs on 18 Apr 2016.

The tender documents can also be downloaded from Sports Authority of India website www.sportsauthorityofindia.nic.in and used for submitting the bids along with the tender document fee of Rs 500/- in the form of DD. Tenders received through e.mail, fax etc will not be considered under any circumstances. **Tender received without EMD and tender fee cost shall be rejected summarily.**

Terms and Conditions

- 1. The rate should be quoted inclusive of all taxes ST/CST/and packing charges etc. and transportation/loading/unloading charges/Installation charges.
- 2. An EMD amount of Rs 10,000/- as Demand Draft drawn in favour of "Centre In-Charge SAI Water Sports Centre" payable at Alappuzha shall be deposited along with the tender documents addressed to THE CENTRE IN-CHARGE, SAI, WATER SPORTS CENTRE, AVALOOKKUNNU PO, PUNNAMADA, ALAPPUZHA. No tenders are accepted without EMD.
- 3. The item should be delivered to SAI Water Sports Centre Alappuzha at the cost of the suppliers.

- 4. The item should be supplied as per the quantity and the specifications mentioned in the tenders and supply order.
- 5. No advance payment will be made at any cost.
- 6. The payment will be made only after delivery of items as per order and specification and by RTGS (Bank Account details to be submitted).
- 7. The minimum period of free service guarantee of the items supplied should be clearly mentioned in the Technical bid.
- 8. 7% of the cost of the items purchased from the successful bidder will be retained as performance guarantee deposit for a period of 60 days from the date of installation of item. The performance guarantee deposit will be released against satisfactory performance of the items supplied.
- 9. The rate of maintenance contract along with period of contract should be maintained against each item in the prescribed column.
- 10. The tender document will be available between 10.00 hrs to 16.00 hrs on all working days (Monday to Saturday except public holidays/2nd Saturdays). The intended bidders may purchase the same from the office of the Centre In-Charge SAI Water Sports Centre Punnamada Alappuzha by making payment of Rs 500/- (Rupees five hundred only) through A/c payee Demand Draft drawn in favour of "The Centre In-Charge SAI Water Sports Centre" payable at Alappuzha or by cash payment.
- 11. The bidders who download the tender documents from the given website are required to pay Rs 500/- (Rupees five hundred only) in form of separate Demand Draft as cost tender documents drawn in favour of the "Centre In-Charge SAI Water Sports Centre" payable at Alappuzha. In case the bid is received without the cost of tender documents, the same will not be considered.
- 12. The quotation Documents duly completed in all respect should be submitted in 3 separate sealed envelopes addressed to CENTRE IN-CHARGE, SAI, WATER SPORTS CENTRE, ALAPPUZHA as per details given below:-
 - (a) Envelope A. Shall contain Demand Draft of Earnest Money for an amount of Rs 10,000/-. The EMD should be deposited in the form of Demand Draft issued by any nationalized/scheduled bank in favour of CENTRE IN-CHARGE, SPORTS AUTHORITY OF INDIA, SAI, ALAPPUZHA along with other details in the format enclosed at Annexure –I. Cover must be sealed and super scribed as **Envelope 'A'**.

- (b) <u>Envelope B.</u> Shall contain Bid consisting of all technical details as per Annexure II along with commercial terms and conditions. The Bidding document duly signed by the tenderer or by his authorized signatory in each page should be submitted in a sealed envelope super scribed as **'Envelope B Technical Bid'**.
- (c) <u>Envelope C</u>. Shall contain the Financial/Commercial Bid indicating the cost of items for supplying to SAI WSC, Alappuzha. The format for submitting the Financial Bid is given in Annexure III & III-A. The cover may be sealed and super scribed as Envelope 'C' Financial Bid.

All the three envelopes should be submitted in one big cover duly sealed. Envelope 'A' & 'B' submitted by the tenderers will be opened on the time and date as given in the tender document. Envelope 'C' will be decided later on.

- 13. Technical bid will be opened, if the EMD along with tender cost (in case downloading from website) is found in order. The Financial Bid of only those bidders will be opened whose Technical Bid is accepted by the Competent Authority. The date, time and venue for opening of Financial Bids shall be communicated to the qualified bidders later on if there is any change in the already notified dates. However, SAI Alappuzha reserves the right for not inviting the unqualified bidders while opening the financial bids.
- 14. Any tender received after the date and time given above will not be entertained under any circumstances.
- 15. The SAI Alappuzha reserves the right to reject or accept any quotation on part or in whole without assigning any reasons thereof at any time.
- 16. All three envelopes should put in a bigger envelope duly sealed and submit the same to The Centre In-Charge SAI Water Sports Centre Avalookkunnu PO, Punnamada Alappuzha 688 006 and super scribed "Tender Form for purchase of Trainer Type Centre Part Rowing Boats (Coxless Four) for Paddling Pool SAI Water Sports Centre, Alappuzha. The cover should also bear the name address of the bidder including telephone number.
- 17. The bidder must put his seal and signatures on each page of the bid as well as supporting documents. The bid shall contain no erasures or overwriting except as necessary to correct errors made by the Bidder, in which case such corrections shall be authenticated by the person or persons signing the bid.
- 18. The bid duly completed in all respect should be inserted in a sealed box placed in the office of SPORTS AUTHORITY OF INDIA Water Sports Centre Punnamada Alappuzha or submitted through post or courier.

- 19. These are only proposed draft, terms & conditions and can be modified, changed or added at the time of final conclusion and signing the agreement.
- 20. In case of any dispute, the matter shall be under the jurisdiction of the court situated at Alappuzha only.
