## TERMS & CONDITIONS FOR SUPPLY

1. The Tender Enquiry shall be submitted in two separately sealed envelopes super scribed on the top left corner of the envelopes as **“TENDER FOR SUPPLY OF SPORTS EQUIPMENT”** and addressed to the Centre In-charge, Sports Authority of India, Training Centre, Indoor Stadium Complex, Calicut, Kerala, PIN – 673 004.
2. **Earnest Money amounting to Rs.10,000/-** (Rupees Ten Thousand) in the form of Demand Draft issued by bank in f/o ‘SAI Training Centre, Calicut’ **and the Technical Bid form** duly signed along with relevant requisitioned documents shall be submitted in **Envelope – ‘A’**.
3. **The Financial Bid** form shall be submitted in **Envelope – ‘B’**.
4. Payment will be released after satisfactory supply and receipt of goods, supplied as per supply order. **The duly filled authorisation letter** for release of Payment through NEFT / RTGS must be submitted along with the bid as per **Annexure – II**.
5. The successful tenderer will have to deposit an amount of Rs.30,000/- (Rupees thirty thousand only) as Security Deposit in the form of Demand Draft issued by bank in f/o ‘SAI Training Centre, Calicut’ and the same will be refunded only after successful supply of the entire orders / settlement of the bills.
6. In case of any defect found in the item/s supplied, the same will be replaced at the cost of Supplier.

8. **Bidders are required to quote their lowest rates for any or all the specified items.**
9. **The quoted SPORTS EQUIPMENT should only be any or all the specified items in the document.**
10. In case of doubt in material the expenditure on testing of material will be borne by the tenderer.
11. The EMD of unsuccessful bidder will be returned within 30 days after the finalisation of the tender.

15. The Centre In-charge, Sports Authority of India, Training Centre, Indoor Stadium Complex, Calicut, Kerala, PIN – 673 004 has the right of awarding the supply order to one supplier of different suppliers for the supply of Sports Equipment.
16. **Bids received without Earnest Money, conditional or incomplete, having cutting or over writing, unsealed are liable to be rejected.**
17. The supplies received, if not found as per the specification of tendered items are liable to be rejected.
18. In case of bidder failing to make the supply in given time and place, SAI shall have the right to purchase the same from the other source at risk and cost of Supplier.
19. The Centre In-charge, Sports Authority of India, Training Centre, Indoor Stadium Complex, Calicut, Kerala, PIN – 673 004 will be legally competent to cancel the contract of supply and also to take any other action against the supplier including imposing of any penalty on the supplier during pendency and till the final execution of the contract of supply, in case the supplier is ever found to have committed any fraud against SAI, training centre, Calicut in supplying the material or indulge in any other malpractices thereof causing any financial losses during contract period.
20. The contract can be terminated or cancelled summarily by SAI in whole or in part any time without assigning any reason, if the supply made by the manufacturer / supplier is not found according to the specification / brand etc., or in case supply is not received within stipulated time.
21. SAI taking into account past performance of party reserves the right to reject any tender.
