### TENDER FOR THE TRANSPORTATION OF SPORTS EQUIPMENTS /PLAYING SURFACE FROM TGHIRUVANANTHAPURAM TO GUWAHATI & SHILLONG FOR SAF GAMES – TERMS AND CONDITIONS

- 1. The items to be transported are sports equipments and playing surfaces.
- 2. The items are located at different offices inside the Trivandrum city.
- 3. The items are to be properly packed, loaded, transported and unloaded at the prescribed destination at Guwhati & Shillong.
- 4. The items are to be returned after the SAF games in the third week of February 2016 and unloaded to the offices from which it was originally collected.
- 5. The rate quoted should include up and down transport, packing/loading and unloading at both the ends, insurance coverage, and all other incidental charges.
- 6. An amount of Rs.25, 000/- to be deposited with the Principal, SAI LNCPE by DD or bank guarantee which will be refunded against no dues.
- 7. The agency will be responsible for the safe transport of items. Any damage caused during the transport will be penalized as per the decision of the competent authority.
- 8. The taxes, if any as per rules will be applicable and recovered from the final billed amount.
- 9. The rate may be quoted for the following vehicles:
  - a. Container vehicle of 20' length and 5.5 ton capacity, single axle.
  - b. Container vehicle of 20' length and 7.0 ton capacity, multi axle.
  - c. Container vehicle of 32' length and 6.5 ton capacity, single axle.
  - d. Container vehicle of 32' length and 14 ton capacity, multi axle.
  - e. Container vehicle of 40' length and 14 ton capacity, multi axle.
- 10. The payment will be made only after the completion of the job satisfactorily and by RTGS.
- 11. In case of break down or non availability of a vehicle offered by the logistics contractor, the logistics contractor shall immediately deploy an equivalent vehicle.
- 12. The vehicle offered should comply with all legal and regulatory norms.
- 13. The Principal SAI LNCPE reserve the right to accept or reject any tender or terminate the entire process without assigning any reason or without any obligation to any of the bidders.
- 14. As most of the items are high valued/sophisticated and most of which are imported and not easily/ timely replaceable, transportation should be done with utmost care and dedication.

- 15. The Principal LNCPE is the final authority in this deal and his decision will be binding on all concerned.
- 16. In case of any dispute, it shall fall under the jurisdiction of courts at Trivandrum.
- 17. The bid should be signed by the authorized signatory of the agency.
