In the event the said mutual discussions/conciliation fail, the aggrieved party shall initiate Arbitration proceedings for resolution of differences / disputes etc., mentioned above by appointing a sole Arbitrator, who shall be the Director General of SAI in which event the said proceeding shall be conducted in accordance with the Provisions of the Arbitration and Conciliation Act 1996.
- 32. The venue of such arbitration proceedings shall be at Bhopal or as decided by Director General of SAI and the courts in Bhopal alone will have Jurisdiction in respect of all proceedings connected there with.
- 33. Sales tax and other charges will be on actual basis and should be included in the rate quoted along with the financial bid.
- 34. The rates of successful tendered will be valid for one year from the date of finalization of sample and rates, no increase on any account will be considered.
