GENERAL TERMS AND CONDITONS

1. The word "LIMITED TENDER ENQUIRY" for Construction of base work of sand running track at SAI CRC Bhopal 2015-16 should be super scribed on the top left corner of envelope bearing the name and address of the tendered. The sealed Tenders Enquiry should accompany the following:-
 - A. A security deposit @ 10% of the total bill will be deducted from total bill amount and release only after six months from the date of completion of the work.
 - B. Tender documents duly signed by tenderer having name of tendered/along with technical details as **Annexure II-A** as per proforma at **Annexure "I" (Envelop-A)**.

All document required as per Annexure-I must be sealed signed by Tenderer.

- C. Financial bids- Rate quoted for goods as per Performa at Annexure – II (**Envelope – B**).
2. The rate/commercial/Technical offer of the firm will remain valid for one year from the date of acceptance/termination of the contract as the case may be.
 3. The Limited Tender Enquiry shall be submitted in two separately sealed envelopes addressed to the REGIONAL DIRECTOR SPORTS AUTHORITY OF INDIA, CENTRAL CENTRE, GRAM GORA BISAN KHEDI POST SURAJ NAGAR , BHOPAL as under :-

Envelope A: This envelope shall contain the documents of the Limited Tender Enquiry documents and information pertaining to present scope of work along with the Limited Tender Enquiry documents duly signed on each page by the tendered or his authorized signatory.

Envelope B: Envelope B shall contain the Financial Bid Documents.

4. The envelopes containing the quotations/ tenders should be sealed and be super scribed," as LIMITED TENDER ENQUIRY FOR CONSTRUCTION OF BASE WORK OF SAND RUNNING TRACK AT SAI CRC BHOPAL as the case may be. 6. Envelope 'B' (i.e. Financial Bid) of only those tendered will be opened, whose Technical bids are accepted and drawing specification are recommended by the tender technical committee. Date and Time for opening of Envelop 'B' (Financial Bid) will be communicated to those whose technical bids are found eligible and sample are recommended the technical committee.
7. The tendered should sign each page of the Limited Tender Enquiry as token of accepting the terms and condition mentioned there in.
8. Late/Vague/ conditional /incomplete/not conforming to the laid down procedure, bids in any respect will be rejected.

9. Offers sent by telex/fax/telegram will not be accepted.
10. In case of differences arising in the terms and conditions of the Limited Tender Enquiry document with the firm (s) the decision of Regional Director, SAI, Bhopal shall prevail.
11. After approval of the tender once set of drawing with technical specification will be retained by the SAI Central Centre, Bhopal without any cost.
12. The scope of work for which the job order indented for shall be completed in full quantity and quality within stipulated time. In case of delay or poor quality of work executed or any other complaint, SAI reserves the right to adjust extra liabilities from the Earnest Money/Security Money.

The scope of work should be as per specification of tender documents approved by the competent Authority.

13. The Limited Tender Enquiry documents are not transferable under any circumstances.
14. The issuing of Limited Tender Enquiry documents shall not constitute that the tendered gets automatically qualified.
15. If even after approval, information/ facts submitted by a tendered are found misleading/incorrect/false etc., SAI reserves right to disapprove an scope of work (s) for the current/ future rate contract or may impose penalties as deemed fit. Non compliance of any of the terms of Limited Tender Enquiry and future instructions by Regional Director, SAI Central Regional Centre, will also warrant above penalties.
16. The tendered are to submit an undertaking to the effect that the material will be used for present scope of work are as per specification laid down in the dossier of Governments at Annexure II-B of this tender, and any discrepancy found later on, the whole amount will be recoverable from the Security Money deposited.
17. The material use for the presence scope of work should be as per approved specification and standard of technical details approved by the tender committee.
18. These are only proposed draft terms and conditions and can be modified, changed or added during final award of contract.
19. The successful tendered will give an Affidavit certifying that the quality of goods quoted in the Limited Tender Enquiry are correct and the concern party is liable to pay damage out of the Security in case of any defect. Regional Director CC may impose penalty as deemed fit and will have right to make recovery from Security or to make deduction from the bill.
20. The successful tendered will have to deposit the Security Money at the rate of 10% of the total value of supply order (or security money @ 10% will be deducted from bill amount) for which no interest will be paid by SAI for the period of its deposit in SAI.

23. In case of delay in complete of work within stipulated date, Regional Director, SAI Central Centre, Bhopal reserves the right of imposing penalty as deemed fit.
24. Taxes as applicable should be inclusive of the rate mentioned in the financial bid no other charges will be paid extra.
25. Payment will be released after satisfactory completion of job for which job order is issued.
26. Regional Director, SAI Central Regional Centre, Bhopal reserves the right to reject any tender in whole or in part thereof without assigning any reason. In case of construction defect, then a penalty of 10% of the total price will become payable to SAI.
27. In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter what so ever touching upon the terms and conditions of the agreement/contract whether in course or on or after its termination the parties agreed to settle the same at the first instance by mutual discussions/conciliation which would be conducted by the Regional Director, SAI Central Regional Centre at Bhopal.
28. In the event the said mutual discussions/conciliation fail, the aggrieved party shall initiate Arbitration proceedings for resolution of differences / disputes etc., mentioned above by appointing a sole Arbitrator, who shall be the Director General of SAI in which event the said proceeding shall be conducted in accordance with the provisions of the arbitration and conciliation Act 1996.
29. The venue of such arbitration proceedings shall be at Bhopal or as decided by Director General of SAI and the courts in Bhopal alone will have Jurisdiction in respect of all proceedings connected there with.
30. Sales tax and VAT will be on actual basis and should be included in the rate quoted along with the financial bid.

Sr. no.	Description & Technical Specification
1. <u>Size</u>	Length of RCC work- 480 mtr x 2 lanes =960 mtr two lanes, Thickness of RCC work- 10 cm Height- 40 cm Both the RCC walls are to be 2.5 mtr apart
2. <u>Earth Work</u>	15 cm of earth of the entire track of above dimension is to be dig and removed and disburse a suitable place.
3. <u>Leveling & rolling of earth base</u>	After removing 15 cm of earth the base of sand track should be level & roll properly so that loosed earth are pressed on ground.
4. <u>Drainage</u>	North Western side underground pipe drain for cleaning water from inside the Track.
