(Coxless Four) – SAI Water Sports Centre Alappuzha" on the top of the envelop and addressed to the Centre In-Charge, Water Sports Centre Alappuzha, PIN – 688006 should reach in the office before 15.00 hrs on 07-09-2015. The tenders will be opened on 07-09-2015 at 15.30 hrs, in the presence of the competitors or their authorized representatives. The financial bid will be opened only if Technical bid is satisfactory and the specification of quoted item is as per the notification. (The details of items required and specification attached).

- 2. Date & Time of opening of tech-bid in SAI Water Sports Centre Alappuzha : 15.30 hrs on 07.09.2015.
- **3.** Earnest Money Deposit Amount : 2 % of the amount quoted.
- 4. Cost of Tender Document : Rs.500/- (Rupees Five Hundred Only).
- 5. Sealed tenders should be dropped in the Tender Box in the office of Centre In-Charge SAI Water Sports Centre, Punnamada Alappuzha.
- 6. Date & Time of opening of financial bid at SAI Alappuzha is 16.30 hrs on 07.09.2015.

#### Terms and Conditions

- 1. The rate should be quoted inclusive of all taxes ST/CST/ and packing charges etc. and transportation/loading/unloading charges/ Installation charges.
- 2. An EMD of 2% of the amount quoted as Demand Draft drawn in favour of "Centre In-Charge SAI Water Sports Centre payable at Alappuzha shall be deposited along with the Tender documents addressed to THE CENTRE IN-CHARGE, SAI, WATER SPORTS CENTRE PUNNAMADA, ALAPPUZHA, No tenders are accepted without EMD.
- 3. The item should be delivered to SAI Water Sports Centre Alappuzha at the cost of the suppliers.
- 4. The item should be supplied as per the quantity and the specifications mentioned in the tenders and supply order.
- 5. No advance payment will be made at any cost.
- 6. The payment will be made only after delivery of items as per order and specification and by RTGS (Bank Account details to be submitted).
- 7. The minimum period of free service guarantee of the items supplied should be clearly mentioned in the Technical bid.
- 8. 10% of the cost of the items purchased from the successful bidder will be retained as performance guarantee deposit for a period of 60 days from the date of installation of item. The performance guarantee deposit will be released against satisfactory performance of the items supplied.
- 9. The rate of maintenance contract along with period of contract should be maintained against each items in the prescribed column.
- 10. The tender document will be available between 10.00 hrs to 16.00 hrs on all working days (Monday to Saturday expect public holidays/II<sup>nd</sup> Saturdays). The intended bidders may purchase the same from the office of the Centre In-Charge SAI Water Sports Centre Punnamada Alappuzha by making payment of Rs.500/- (Rupees Five Hundred only) through A/C payee Demand Draft/Pay order drawn in favour of "The Centre In-Charge SAI Water Sports Centre payable at Alappuzha or **by cash payment.**

The date, time and venue for opening of Financial Bids shall be communicated to the qualified bidders later on if there is any change in the already notified dates. However, SAI Alappuzha reserves the right for not inviting the unqualified bidders while opening the financial bids.

- 13. Any tender received after the date and time given above will not be entertained under any circumstances.
- 14. The SAI Alappuzha reserves the right to reject or accept any quotation on part or in whole without assigning any reasons thereof at any time.
- 15. The Bids shall be submitted in three separate sealed envelopes as under:-
- a) Envelope A Should contain the Bank Drafts for the EMD & Receipt/Bank Draft of Tender Cost.
  - b) Envelope B Should contain the Technical Bid Document duly signed by the bidder on each page. All necessary documents are to be submitted along with the Technical Bid.
  - c) Envelope C Should contain the Financial Bid Documents.
