TENDER NOTICE

Sub: Disposal of Collapsed pavilion at Athletic Stadium SAI LNCPE on scrap value

DISPOSAL OF COLLAPSED PAVILION AT SAI, LNCPE

Spot auction cum sealed tenders are invited from competent firms/individuals for disposal of collapsed pavilion at Athletic Stadium SAI LNCPE, Karyavattom, Thiruvananthapuram, Pin-695581 on scrap value.

The list of item to be auctioned is placed at Annexure "I". The disposal of these items will be on "AS IS WHERE IS" basis subject to terms and conditions mentioned below. The sealed cover containing highest offer in the enclosed proforma may be sent to the Principal, LNCPE, Karyavattom, Thiruvananthapuram, Pin-695581. The spot auction will be held in the campus on 03.05.2022 at 4 pm.

- 1. The cover of the envelop should be prominently super scribed with the words " QUOTATION FOR DISPOSAL OF COLLAPSED PAVILION AT SAI, LNCPE"
- 2. The collapsed pavilion in the SAI LNCPE, Karyavattom, Thiruvananthapuram, Pin-695581 will be open for inspection between 10.00 am to 5.00 pm on all working days. Interested parties are required to sign the register after the inspection of site.
- 3. The tender should reach in the office of Principal on or before 3 pm on 03.05.2022. The tender will be opened in the presence of the bidder or their authorized representatives after the spot auction held.
- 4. THE SALE WILL BE GOVERNED BY THE FOLLOWING TERMS AND CONDITIONS.
- i) The details of collapsed pavilion are mentioned in the tender form, which can be obtained from the office after paying Rs.500/-plus GST. The tender should be accompanied by an earnest money of Rs. 10,000/- (Rupees Ten Thousand only) in the form of bank draft/Pay Order drawn in favour of Principal, LNCPE, Kariavattom, Thiruvananthapuram. The earnest money will be returned to all the unsuccessful bidders after the finalization of tenders. The tenders received without earnest money shall be summarily rejected. The tender will be opened immediately after spot auction.
- ii) The total value of dismantled items shall be calculated based on the rate quoted by the bidder multiplied with the actual quantity of items available. The quantity of items shall be measured by using weighing bridge or platform weighing machine in the presence of the successful bidder. The work will be awarded to the successful bidder who has quoted or called highest rate for all the items together and it should be above the floor price fixed by the college.

- iii) The successful bidder will be required to deposit 25 % of the bid amount immediately on spot itself and balance amount to be paid within 7 days quoted in full before finalizing the work. The payment for the sold items will be accepted either in cash to be deposited with the Cashier, LNCPE, Kariavattom, Thiruvananthapuram in the form of Bank Draft/Pay Order drawn in favor of Principal, LNCPE, payable at Thiruvananthapuram.
- iv) No complaint about the quantity, quality or condition of material will be entertained after opening of the tenders. The items would be handed over to the highest bidder on "as is where basis". SAI, LNCPE shall not be responsible for their usefulness or quality.
- v) The highest bidder will be required to take all the dismantled materials within seven days after acceptance of the tender.
- vi) SAI,LNCPE will not incur any incidental expenses (such as loading, transport etc.) at any reason for shifting of items.
- vii) The earnest money and immediate deposit (25% of the bid amount) of successful tenderer (bidder) will be forfeited if he fails to lift all the items within seven days after acceptance of the tender.
- viii) The earnest money of unsuccessful bidders shall be released only after the successful bidder take delivery of the sold goods. All the bidders should have a valid PAN Card and relevant taxes will be collected from the successful bidder over and above the quoted as per existing tariff. (GST/ TCS charges & Income Tax)
- ix) Principal, LNCPE reserves the right to accept or reject any or all the quotations without assigning any reasons thereof.
- x) The quotation not received in Annexure-I will be rejected. Any rate quoted for items in part and any manner other than for the whole lot of items shall be acceptable and such tenders shall be summarily rejected.
