A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. - c) Certificate of Chartered Accountant showing annual turnover for the last three financial years i.e. 2019-20, 2020-21 & 2021-22. Copies of Balance Sheet, Profit and Loss Account statement etc need not be enclosed.
- d) Copy of Labour Licence, EPF & ESIC Registration.
- e) Undertaking regarding not blacklisted or debarred by any Govt. entity.
- f) Bidder should have its Geographic Presence: An office of the service provider must be located at Himachal Pradesh. Documentary evidence of the same to be submitted.
- g) Bid Security Declaration Form in lieu of EMD. Bidders are mandatorily required to submit, "Bid Security Declaration" as per format enclosed as "Bid Security Declaration Form". In case a bidder does not submit the aforesaid declaration then the bid shall be considered non-responsive and will be rejected.
