- 7. Applicable Tax such as GST/TCS etc. If any as per Government norms shall be paid by vendor which will be in addition to quoted price / amount.
- 8. Weighment: should be done in the presence of SAI official. If required use of weighing bridge, cost will be bare by vendor cost.
- 9. Prices will be offered in lot wise, however, payment shall be made by vendor on prorata basis i.e., based on the actual weight / quantity at the time of lifting of scrap / asset.
- 10. **Permission for lifting the material:** The material can be lifted up from the site, only after submission of complete amount and issuance of Gate Pass/certificate from SAI RC Gandhinagar.
- 11. All the charges i.e., loading, unloading and transportation to be incurred in course of lifting of items from the designated placed shall be borne by the successful bidder. - 15. No complaint regarding the quality or description of the material sold will be entertained once the bid has been accepted. It will be considered that the agency has done the inspection and evaluation of the obsolete items before applying in the bid.
- 16. In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the articles in the schedules time, this office shall not take responsibility for safe custody of the articles.
- 17. No damage shall be caused to the existing property of this office or any other offices in the premises while removing the materials from the site. Any loss/damage to the property of this office or any other offices in the premises or injury or personal accident suffered by any person due to negligence or action of the successful bidder or his authorized worker/ supervisor will be borne by successful bidder.
- 18. While taking delivery of the materials it will be at discretion of the authorized Representative of Company to decide the manner in which materials shall be removed. No segregation of the materials will be entertained at SAI RC Gandhinagar.
