- 4. The contract shall afford every reasonable facility for the carrying out of all works relating to the work in the manner laid down in the said conditions, and shall make good any damages done to walls, floors, etc. after the completion of such works.
- 5. The Employer reserves to itself the right of altering the Drawings and nature of the work by adding to or omitting any items of work or having portions of the same carried out without prejudice to this Contract.
- 6. All payments by the Employer under this contract will be made only by NEFT/RTGS/ Net banking.
- 7. All disputes arising out of or in any connected with this agreement shall be deemed to have arisen at Bangalore and only court in Bangalore shall have jurisdiction to determine the same.
- 8. That the several parts of this Contract have been read by the Contractor and fully understood by the Contractor. The Contractor shall not be entitled for the payment for the quantities beyond the tendered quantities unless ordered for by specific written instructions from the Architect / Engineer.
