However, the language of any printed literature furnished by the Bidder in c onnection with its Bid may be written in any other language provided the same is accompa nied by an English translation, and, for purposes of interpretation of the Bid, the English tr anslation shall prevail.

#### 3. Biding Expenses

  - 7.2 The unit price shown in the financial bid will be inclusive of all charges, taxes & duties, transp ortation, loading & unloading & GST.

### 7.3 Bidder should quote prices for all items i n Requisition List.

- 7.4 It is the responsibility of Bidder to go through the Bidding Document before offering rates as p er price schedule.
- 7.5 A Bidder, who did not fulfill any of the above requirements and / or gives evasive information / reply against any such requirement, shall be liable to be ignored and rejected.

However, in respect of GST, if payable, same shall be paid by the bidder to the concerned department on dem and and it will be reimbursed to him by the SAI after satisfying that it has been actually and ge nuinely paid by the bidder.

#### 11 Documents establishing bidder's eligibility and qualifications

The bidder shall furnish, as part of its bid, relevant details and documents establishing its quali fications as stipulated in Bid Document to perform the contract.

### 12 Bid Security/Earnest Money Deposit (EMD )

### 14 Scrutiny of Bids

- 14.1 The SAI will examine the Bids to determine whether they are complete, whether any computati onal errors have been made, whether required sureties have been furnished, whether the doc uments have been properly signed stamped and whether the Bids are generally in order.
- 14.2 The bids will be scrutinized to determine whether they are complete and meet the essential re quirements, conditions, etc. as prescribed in the Tender document. The bids, which do not mee t the basic requirements, are liable to be treated as non-responsive and will be summarily igno red.
- 14.3 The following are some of the important aspects, for which a bid shall be declared non respon sive and will be summarily ignored;
  - a) Qualification Criteria not enclosed.
  - b) Bid validity is shorter than the required period.
  - c) Bid Security have not been provided in hard copy.
  - e) Bidder has not agreed to give the required performance security.
  - f) Bidder has not agreed to other essential condition(s) specially incorporated in the bid enquiry like terms of payment, liquidated damages clause, warranty clause, disp ute resolution mechanism applicable law.
  - g) Bidder has not quoted as per the Price Schedule

### **15 Discrepancies in Prices**

- 15.1 If, in the price structure quoted by a bidder, there is a discrepancy between the unit price and th e total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly unless the SAI feels that the bidder has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shal I prevail over the unit price and the unit price corrected accordingly.
- 15.2 If there is an error in a total price, which has been worked out through addition and/or subtractio n of subtotals, the subtotals shall prevail and the total corrected, and
- 15.3 If there is a discrepancy between the amount expressed in words and figures, the amount in wor ds shall prevail.
- 15.4 If, as per the judgment of the SAI, there is any such arithmetical discrepancy in a bid, the same w ill be suitably conveyed to the bidder by mail. If the bidder does not agree to the observation of t he SAI, the bid is liable to be ignored.

# **16 Qualification Criteria**

Bids of the Bidders, who do not meet the required Qualification Criteria will be treated as non - r esponsive and will not be considered further.

# **17 Comparison of Bids and Award Criteri** a.

17.1.1 The Contract shall be awarded to the responsive Bidder(s) who is **Overall Lowest** and wh o meets the laid down Qualification Criteria in the Bid documents. This means that award criteria will be based on the least rates, which would be total payout including all taxes, d uties and levies.'

# **18 Contacting the SAI**

18.1.1 In case a bidder attempts to influence the SAI in the SAI's decision on scrutiny, compariso n & evaluation of bids and awarding the contract, the bid of the bidder shall be liable for r ejection in addition to appropriate administrative actions being taken against that bidder, as deemed fit by the SAI.

# **D. AWARD OF CONTRACT**

### 19 Notification of Award

- 19.1.1 Before expiry of the bid validity period, the SAI will notify the successful bidder in writing, by GeM Portal/ registered / speed post or by fax/ email that its bid for items, which have b een selected by the SAI, also briefly indicating there-in, that the essential details like desc ription and prices have been accepted. The successful bidder must furnish to the SAI the required Performance Security within **10** (Ten) **days** from the date of dispatch of this noti fication, failing which the Bid Security will be forfeited and the award will be cancelled.
- 19.2 The details of award of work and name of the successful bidder shall be mentioned on the GeM Portal.
- 19.3 Notification of Award shall constitute the conclusion of the Contract.

# 20 Variation of quantities at the time of award

During execution of the contract, the SAI reserves the right to increase or decrease, the quant ity of items mentioned in the "Price Schedule/Scope of Work" up to 25 (Twenty-Five) percent (rounded off to the next whole number) without any change in the unit price and other terms & conditions quoted in the bid by the bidder.

# 21 Annulment of Award

Failure of the successful bidder to comply with the requirement of signing an agreement with the SAI and furnishing Performance Security shall constitute sufficient ground for annulment of the award and forfeiture of bid security.

# 22 Termination of Contract

The SAI reserves the right to terminate the contract. Before termination of contract, SAI will n otify the service bidder giving a notice of 30 days.

# 23 Disqualification

SAI reserves the right to disqualify the bidder for a suitable period who fails to provide the ser vices in time.

### 24 Non-receipt of Performance Security and Contract by the SAI

Failure of the successful Bidder in providing Performance Security and / or returning Contract

copy duly signed make the Bidder liable for forfeiture of its Bid Security and, also, for further actions by the SAI against it including termination on default and other administrative actions as deemed fit by the SAI. Any concurrent or collateral or incidental financial loss incurred by the bidder in discharge of award of contract process, SAI wont be deemed to be liable and th ereby be responsible for damages what-so-ever.

#### **Corrupt or Fraudulent Practices** 25

It is required by all concerned namely the Authority/Bidders/Service providers etc. to observe the highest standard of ethics during the procurement and execution of such Contracts. In pu rsuance of this policy, the SAI: -

- will reject a proposal for award if it determines that the Bidder recommended for a (a) ward has engaged in corrupt or fraudulent or collusion or coercive practices in compe ting for the Contract in question;
- will declare a firm ineligible or blacklist, either indefinitely or for a stated period of ti (b) me, to be awarded a Contract by the SAI if it at any time determines that the firm ha s engaged in corrupt or fraudulent or collusion or coercive practices in competing for , or gross / deliberate negligence in executing the Contract. The SAI reserve the right not to conclude Contract and in case Contract has been
- (c) issued, terminate the same, if found to be obtained by any misrepresentation, conce alment and suppression of material facts by the Bidder. In addition, Performance Sec urity deposited by the Bidder shall be forfeited and legal as well as administrative act. ion for such misrépresentation, concealment & suppréssion of material facts shall be i nitiated.

# 26. Conflict of Interest among bidders/agents

A bidder shall not have conflict of interest with others bidders. Such conflict of interest can lea d to anti-competitive practices to the detriment of SAI's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of inter est with one or more parties in this bidding process if;

- a) they have controlling partner (s) in common; or
- b) they receive or have received any direct or indirect subsidy/financial stake from any of them: or
- they have the same legal representative/agent for purposes of this bid; or c)
- d) they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidd er: or
- bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one Bid will result in the disqualification of all bids in which the parties are invol e) ved. However, this does not limit the inclusion of the components/ sub-assemblies from one bidding manufacturer in more than one bid.
- f) in case of a holding company having more than one independent units, or more than one u nit having common business ownership/management, only one unit should quote. Similar res trictions would apply to closely related sister companies. Bidders must proactively declare su ch sister/common business/management units in same/similar line of business. a)
  - Surrogate bidding is not permissible.

#### 27. Blacklisting Clause/ Debarment clause

Blacklisting Clause/ Debarment clause be incorporated more vividly in consonance to the Ministr y of Finance guidelines issued vide Office Memorandum No. F.1/20/2018-PPD dated 2nd Novemb er, 2021. The Debarment of a firm shall be passed by a Ministry/Department/Organization, keepi ng in view the following:

- A bidder or any of its successors may be debarred from participating in any procurement process for a peri a) od not exceeding two years.
- Firms will be debarred, if it is determined that the bidder has breached the code of integrity as per Rule 17 b) 5 of GFRs 2017.
