During the CMC period commencing from date of the successful completion of warranty period, Service personnel shall visit each consignee as recommended in the manufacturer's technical/service /operational manual, at least once in six months or as per requirement. Cost of consumables shall not be included in CMC.Further there will be 98% uptime warranty during CN period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend CMC period by double the downtime period. 2.CMC charges to be indicated as percentage of cost of equipment quoted for each year after the warranty period. 3.GST shall be included in the CMC Charges quoted.

4.Cost of CMC will be added for Ranking/Evaluation purpose with depreciation formula. A 10% discounting rate per ye shall be applied on CMC Charges for price evaluation on Net Present Value.

5. The payment of CMC will be made on quarterly basis after satisfactory completion of said period, duly certified by user.

6.While creating a bid or RA, buyers shall indicate whether CMC is required against Yes/No" options. If CMC Charges included, an option for number of years for CMC required after the warranty period shall be available. Under this optiup to 10 years can be chosen for CMC charges beyond warranty period.
