1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 4. Certificates

5. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

Terms and conditions:

- Service provider is required to pay salaries / wages of contracted staff deployed at buyer location first i.e. on their own which can be up to three months and then claim payment from buyer along with all statutory documents like PF, ESIC challan PT etc. as well as the bank statement of salary to staff along with salary slip. - 6) Solvency certificate minimum 23 lakhs from bank (not above six month)
- 7) Should furnish valid ISO certificate for providing Security guards services
- 8) Should have minimum 3 years experience in providing Security guards services
- 9) Should submit minimum wages compliance certificate from the current client statin g that the contractor is paying wages in accordance with minimum wages notified b y the Chief Labour Commissioner Central to the employees engaged in various day-t o-day activities.
- 10) Should submit proof of remittance of ESIC, PF, GST etc.
- 11) Should have registered under GST Act.
- 12) ITR for past 03 years along with balance sheet and profit & loss statement (FY. 202 0-21, 2021-22 and 2022-23)
- 14) Current client list with contract details.

- 15) The service provider is required to have at least 50% of the required Security Guar ds services provider payroll for at least one year. Necessary documents relating to s uch Security Guards service will be uploaded by the bidder for verification of the buy er.
- 16) Undertaking regarding not blacklisted or debarred by any Govt. entity (format enclo sed)
- 17) Successful bidder needs to provide police verification certificate, medical fitness cer tificate and address proof of the engaging manpower to SAI, NCOE Aurangabad.

8. Purchase Preference (State)
