- 8) Should have minimum 3 years experience in providing services of manpower in the field of civil and electrical departments
- 9) Should submit minimum wages compliance certificate from the current client stating that the contractor is paying wages in accordance with minimum wages notified by the Chief Labour Commissioner Central to the employees engaged in various day-to-day activities.
- 10) Should submit proof of remittance of ESIC, PF, GST etc.
- 11) Should have registered under GST Act.
- 12) ITR for past 03 years along with balance sheet and profit & loss statement (FY. 2020-21, 2021-22 and 2022-23)
- 13) Current client list with contract details.
- 14) The service provider is required to have at least 50% of the required civil, electrical maintenance services provider payroll for at least one year. Necessary documents relating to such said services will be uploaded by the

bidder for verification of the buyer.

- 15) Undertaking regarding not blacklisted or debarred by any Govt. entity (format enclosed)
