If the bidder wants to avail themselves of the Purchase preference the bidder must be the manufacturer / OEM of the ordered product on GeM. Traders are excluded from the purview o

Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by so other OEM are not eligible for any purchase preference. During the CMC period commencing from date of the successful completion of warranty period, Service personnel shall visit each consignee as recommended in the manufacturer's technical/ service /operational manual, at least once in six months or as per requirement. 13.CMC Charges are inclusive of all the charges for Transportation, Lodging, Boarding, all insurances including third party insurance and all other incidental charges. The same shall include GST. The prices also include cost of spares a damaged parts. Purchaser does not have any liability, whatsoever, over and above the cost of CMC. It also includes 1 arranging hand tools & tackles, special tools etc. required to carry out the work.
